## SECTION I.

## THE COMPETITION

## 1. TITLE

The Competitions for boys and girls aged 16, 14 and 12 years \& Under shall be called the Tennis Europe Winter Cups by HEAD.

## 2. MISSION STATEMENT

The Tennis Europe Junior Tour is owned and managed by Tennis Europe and consists of individual tournaments held in its 50 member nations and divided into the three different age categories (12\&U, 14\&U, 16\&U) for boys and girls.

The aim of the Tour is to promote and develop Junior Tennis within Europe, offering international tournaments of various levels, whilst also allowing 14\&U and 16\&U players to progress within the Tennis Europe Rankings system. The Tour also strives to prepare the best European and non-European players aiming to progress to other tours, and in addition provides an early experience of international team events.

## 3. OWNERSHIP

The Competition shall be owned by and under the direction and control of Tennis Europe.
Ownership shall include, but not be limited to the following national and international rights: registered trademarks of Tennis Europe; commercial exploitation of the event; television and radio, film and video recordings. The Board of Management may assign rights to the Host Nation in accordance with detailed guidelines issued by Tennis Europe consistent with these regulations.

Tennis Europe is the exclusive rights owner regarding live scoring and live streaming from Tennis Europe Junior Tour events.

For 2019, these rights are hereby granted to the Host Nation/Local Organiser of each event for their own use. Please note that Tennis Europe should be informed in advance of any live scoring/streaming plans.

## 4. NATIONS ELIGIBLE

The Competition shall be open only to members of Tennis Europe.

## 5. DATE

The Competition shall be played, in principle, at the following times: Qualifying Rounds end of January, Final Rounds in February.


## 6. FORMAT

The Final Rounds of the Competition, incorporating 8 boys and 8 girls teams, shall be played on a knock-out principle, at one venue.

Qualifying Rounds shall be held to decide the 8 boys and 8 girls teams for the Final Rounds of the Competition.

## 7. RULES TO BE OBSERVED

The Competition shall take place in accordance with these Regulations, the Rules of the ITF, the Rules of Tennis adopted by the ITF, and the approved Code of Conduct.

In submitting an entry, a Nation, and its team members, including the captain, automatically undertake to abide by and fulfil all their obligations under the above Rules and Regulations.

Any Nation, and its team members, including the captain, failing to honour this undertaking shall be subject to penalties given in the code of conduct of these Regulations.
In submitting an entry, a Nation, its officers, directors, employees and its team members agree, as a condition of entry, that for themselves, their executors, administrators, heirs and personal representatives, all claim of any kind, nature and description are waived, including past, present or future claims and injuries, if any sustained in traveling to or from, or participating in the competition, against ITF, Tennis Europe, the Host Nations and sponsors of the competition.

Each team member of each Nation that enters and/or participates in the Competition, and any Player Support Team Member of each team member and each Nation that enters/and or participates in the Competition shall be bound by and shall comply with the provisions of the Welfare Policy set out in Appendix 6.

## SECTION II.

## MANAGEMENT

## 8. MANAGEMENT

The Competition shall be managed by the Tennis Europe Board of Management in cooperation with the National Association of the country where the Final Rounds (or Qualifying Rounds) of the Competition are played (Host Nation).

## Board of Management - Duties

The duties of the Board of Management shall be:
(i) To decide the entry fee and allocation of any prizes.
(ii) To administer the funds of the Competition within the financial framework of Tennis Europe.
(iii) To decide any appeals or dispute arising among Nations participating in the Competition.
(iv) To impose penalties laid down in these Regulations.

(v) To have full authority to decide disputes arising in connection with all financial matters. Junior Committee - Duties

The duties of the Junior Committee shall be:
(i) To select the venues and decide the dates for each of the Qualifying competitions and the final stages of the Competition.
(ii) To be responsible for overseeing the management and presentation of the Competition.
(iii) To approve the appointment by the Host Nation of a Tournament Director for the final stages of the Competition.
(iv) To appoint the Referee and approve the appointment of any assistant referees for the final stages of the Competition by the Host Nation.
(v) To recommend to the Board of Management the venue and dates for each of
the Qualifying competitions and the final stages of the Competition, the entry fee and allocation of any prizes.
(vi) To report to the Board of Management on all financial matters relating to the event.
(vii) To recommend to the Board of Management any penalties to be imposed in accordance with these Regulations.
(viii) To undertake other duties as laid down in these Regulations.

## Tournament Committee - Duties

For the Final Rounds of the Competition a Tournament Committee shall be formed, to include the following:

1. Chairperson, or other representative of the Championship;
2. Representative of the Organising Club;
3. Tournament Director from the Host Nation;
4. Referees.

## Honorary Committee

The Honorary Committee shall include the President of Tennis Europe, the Chairman of the Tennis Europe Junior Committee, the President of the Organising National Association, the President of the Club, some personalities of the organising Country, Area and City.

## SECTION III.

## ARRANGEMENTS FOR THE COMPETITION

## 9. FINAL ROUNDS

The Organisation of the Final Rounds of the Tennis Europe Winter Cups by HEAD 16/14/12 \& Under is granted by the Tennis Europe Junior Committee to different European National Associations,

Any National Association wishing to stage a Final Round of the Competition shall submit an application in writing to Tennis Europe by 1 September of the preceding year.

## 10. APPLICATIONS TO STAGE A QUALIFYING ROUND

Any National Association wishing to stage Qualifying Rounds of the Competition shall submit their preliminary application in writing to Tennis Europe by 1 September of the preceding year.

## 11. VENUES

The Junior Committee shall select and announce the venues for the Final Rounds and Qualifying Rounds.

## 12. FINANCIAL GUIDELINES FOR ON-SITE ORGANISATION

The financial guidelines for the on-site organisation shall be circulated by Tennis Europe to the Host Nation.

## 13. FACILITIES

The Host Nation shall appoint a Tournament Committee who shall arrange accommodation and court facilities for the teams to compete.

The Organisers will cover the expenses for accommodation and meals for three players and a non-playing captain of each team from their arrival the day before the start until the morning following the end of the competition. Each participating National Association is responsible for their own travelling expenses.

## 14. SURFACE OF COURT

The Competition is to be played preferably on hard courts indoors.
The Tennis Europe Junior Committee can decide to play outdoors and/or on a different surface on special request.

## 15. MAKE OF BALLS

Tennis Europe has the right to select the make of balls to be used in the Events (Qualifying Rounds and Finals).

For the 2019 Tennis Europe Winter Cups by HEAD, the selected ball shall be HEAD Tour.


There shall be a minimum of three new balls for each match; another three new balls shall be provided for any third set.

Balls shall be provided for practice, but it shall not be obligatory to give new balls for this purpose.

## 16. MEDICAL ASSISTANCE

The Host Nation must ensure that a Sports Physiotherapist, nurse or suitably qualified trainer is present on-site throughout the competition.

A doctor must be available, preferably on-site, throughout the competition. If not, he must be available on call and be able to be on-site in a very short time.

In case there is no doctor on-site when a problem occurs, the Sports Physiotherapist can decide to continue the match without calling the doctor.

## 17. OFFICIATING

The Referee designated by the National Association must be minimum an ITF White Badge Referee.

## SECTION IV.

## ENTRIES AND TEAMS

## 18. ENTRIES

Entries from National Associations are to be sent so as to reach Tennis Europe by $1^{\text {st }}$ September of the year preceding the Competition. All competing nations shall receive the final list of entries following this date.

## ENTRY-FEES

An entry fee of Euros 250. - per age category (boys and girls separated) is payable to Tennis Europe with the mention "Tennis Europe Winter Cups by HEAD 16/14/12 \& Under.

## 19. COMPOSITION OF TEAMS

Each team shall consist of a maximum of three players and a non-playing Captain.
In order to be eligible to compete, a team should have a maximum of three players on site and available to play.
If, for reasons of health, injury or bereavement, a team is able to field only two players, such team will be permitted to participate only if written approval is obtained from Tennis Europe prior to start of the Competition.

## 20. NOMINATION OF TEAMS

Nominations of individual players in order of merit for singles, and the non-playing Captain, must be received by Tennis Europe two weeks before the scheduled first day of play for the Final Rounds of the Competition.

The lists with the nominated players will be published on the Internet and officially sent to the local organisers with the respective ranking and Order of Merit before the start of the captain's meeting.

## 21. CHANGE OF NOMINATIONS

A National Association may change its nominations up until one hour before the captains' meeting which will be held prior to the draw.
Where possible changes to nominations, should be notified in writing to Tennis Europe seven (7) days before the date of commencement of play.

Tennis Europe must take such changes into account when determining the final seeding's.
For the 12 \& Under the final order of merit will be reconfirmed by the Team captains onsite during the captains meeting

## 22. PASSPORTS

On site: The Captain shall present passports of all team members, and shall present photo identification, including date of birth, for himself/herself, to the Referee prior to the start of the Captains'Meeting. Failure to present passports by the time determined by the Referee may render a team liable to disqualification.

## 23. CHANGE TO ORDER OF MERIT

The Order of Merit may be changed up to seven (7) days prior to the scheduled first day of play for the Competition. Thereafter no change may be made to the order of merit sent by the National Association. For the $16 / 14$ \& Under, the final Order of Merit of a team will be based on the latest available rankings (Tennis Europe Junior Ranking) and sent to the local organisers of the event before the captain's meeting.

If there is a change in the nominations of the players, one hour before the Captains meeting, the Referee shall establish the order of merit of the team based on the latest available rankings (Tennis Europe Junior Ranking). For the 12 \& Under the final order of merit will be reconfirmed by the Team captains onsite during the captains meeting.

## 24. RIGHTS TO USE NAME AND LIKENESS

In accepting nomination, a player automatically grants to Tennis Europe and the Host Nation the right in perpetuity to make, use and show, from time to time and at their discretion, any motion pictures, still pictures and live, taped or film television and other reproductions of him or her during the said Competition, without compensation.

## 25. ELIGIBILITY

16 \& under
14 \& under
12 \& under: According to the ITF Rule (see Appendix 3). However, a nation wishing to enter a player of the category 12 \& under in the $14 \&$ under event must send a written application to Tennis Europe.

## 26. QUALIFICATION OF A PLAYER TO REPRESENT A COUNTRY (ITF RULE)

A player is entitled to represent one nation only at ITF World Junior Tennis and Junior Davis Cup and Fed Cup competitions.
(a) Any tennis player who is in good standing with his/her National Association in accordance with Appendix $F$ shall be qualified to represent that nation as a player if he/she:
i. Is a citizen of that nation and has a current valid passport of that nation;
ii. Is a citizen of that nation, but in circumstances where that nation does not issue its own passport holds a qualifying passport issued by or on behalf of that nation which confirms the player's place of birth as that nation; or
iii. If after a consecutive period of 2 years ( 24 months) residence in that nation can provide a genuine reason for being unable to hold or make application to hold a current passport where:
a) He/she was born, or has a parent or grandparent born, in that nation; or
b) $\mathrm{He} /$ she has obtained or procured the right to remain permanently or has been granted humanitarian protection in that nation.
If a player is qualified under this sub-section above to represent more than one nation and the National Association of one of those nations wishes to nominate him/her to represent it, that Association must submit an application to the Tennis Europe Manager who will forward a copy to any other National Association concerned, which shall be entitled to comment within 15 days of receipt. The initial application must be received by the Tennis Europe Manager at least three months prior to the event for which the player wishes to be nominated.
In addition, if a player has represented a nation at regional international junior team competition level and he/she is qualified under this sub-section to represent another nation, that national association must submit an application to the Tennis Europe Manager who will forward a copy of the application to any other national association concerned, which shall be entitled to comment within 15 days of receipt. The initial application must be received by the Tennis Europe Manager at least three months prior to the event for which the player wishes to be nominated.
The Tennis Europe Manager will give a ruling having taken into account all relevant matters.
(b) i. A player who has represented, or has been eligible to represent a nation and such a nation is divided into two or more nations, shall immediately be eligible to represent any one of those nations. ii. A player who has represented, or has been eligible to represent a nation and such nation is absorbed in whole or in part by another nation, shall immediately be eligible to represent such other nation.
(c) A player shall be deemed to have represented a nation if he/she shall have been nominated and shall have accepted the nomination to play in the
Olympic Games Tennis Event, the Youth Olympic Tennis event or in any International Team Competition recognised by the ITF and listed in Bye-law 2.1 (a).

(d) A National Association may appeal to the Tennis Europe Junior Committee to nominate a player who is not eligible under the above Regulations and the said Committee may agree to the application if the full circumstances warrant an exception being made. Such applications must be received by the Tennis Europe Manager at least three months prior to the event for which the player wishes to be nominated.
(e) The Tennis Europe Junior Committee and/or the Organising Committee of the event have the right to ask a National Association to produce evidence to show how a player is qualified to represent that nation.
(f) The Tennis Europe Junior Committee can only approve exceptions for players to participate in the competitions of that Committee.
A player can represent another Nation at Regional Competitions

## 27. THE CAPTAIN

The Captain shall be allowed to sit on court beside the chair of his/her team but he/she may not move away from that area and in particular may not cross the net to the opposite side of the court. Apart from his/her team, he/she may talk to the Chair Umpire and, in case of an appeal on a question of tennis law, to the Referee. He/she may not talk to any Line Umpires. If the Captain is unable to fulfil his/her duties on court he/she may be replaced only by one of the nominated players who shall be allowed to sit on court and who shall under these circumstances be permitted to talk to the chair umpire and/or request to talk to the Referee.

The Referee shall have the authority to give a formal warning to the Captain and, after two warnings, may remove him from the match in course and/or for the following matches of that Tie, in which case he may be replaced only by a member of the nominated team. The Referee may also remove the Captain without a formal warning for a single incident of misconduct. In addition to removal, the Captain is subject to the applicable provisions and penalties of the Code of Conduct.

The Captain, who must be a minimum of 24 years of age prior to the end of the calendar year in which the competition is played (unless approved by Tennis Europe in writing), shall qualify regardless of his/her nationality and shall be subject to the rules which apply to members of his/her team. A Captain shall be able to represent one nation only during a calendar year. The captain is required to have a coaching qualification recognised by the National Association concerned.

## 28. MEDICAL CONTROL

National Associations entering the competition and those players nominated to compete on their behalf agree, as a condition of entry, to the following medical controls:

## (a) Tennis Anti-Doping programme

Random doping control tests may be conducted during the Competition in accordance with Bye-law 8 of the Constitution of ITF Limited. (See Appendix 9).
If any player following completion of the procedures, including appeal, set forth in Bye-law 7 of the Constitution of ITF Limited is found to have tested positive, no match results shall be re-assessed except in the case of the final where such player's wins (if any) will be reversed. This may result in the team, which originally lost the Final being declared the Champion Nation. Such player will be subject to penalties laid down in Bye-law 7 of the Constitution of ITF Limited.
(b) Waiver of claims

It is acknowledged that the ITF have a duty to act on any reported positive test and it will act in the manner set out in this Regulation. Further, all parties, be they a National association or player, accept that the ITF must act on the information known to it at the relevant time and accordingly:
(i) A National Association having been declared loser of the Final as a result of a positive test of any of its players, agrees to waive any rights to legal action or compensation from the ITF in circumstances resulting from this regulation.
(ii) Nominated members of any European Team Competition agree to waive any rights to legal action or compensation from the ITF in circumstances resulting from this regulation.

## 29. PUBLIC LIABILITY INSURANCE

The applicant is responsible for taking out a suitable insurance policy which is compliant with local laws and regulations and which insures against claims made for damage to property and for death/injury caused to people at the event for which the applicant is legally liable.

## 30. INSURANCE

National Associations are responsible for ensuring that all members of their team(s), and any accompanying officials in their delegation, are fully and adequately covered by insurance for the purposes of attending and participating in the event. Tennis Europe/ITF, the title sponsor, the host association and the host venue cannot accept any liability for any participant of visitor in this respect.

All players are required to have adequate medical, travel and liability insurance, which is not provided by either Tennis Europe, the host National Association or the local organiser.


## 31. CAPTAIN'S MEETING

A Captain's Meeting shall be held on the day prior to the commencement of the Competition.
All team Captains are required to attend the Captains Meeting organised for them by the Tournament Director and Referee, unless reasonably unable to do so, and as determined by the Referee. Failure to be present at the Captains Meeting, without any exception determined by the referee may render to a team liable to disqualification. In case to disqualification, the final decision lies to Tennis Europe.

## 32. WAIVER OF CLAIMS

All players and National Associations entering the Competition agree, as a condition of entry, that for themselves, their executors, administrators, heirs and personal representatives, all claims are waived, including past, present or future against the ITF, Tennis Europe or the Host Nation with respect to any cancellation, any injuries, however caused, or any losses incurred while traveling to and from, or participating in the competition.

Each player/National Association grants and assigns to Tennis Europe, the ITF, the tournament's sanctioning National Association, the tournament and their agents and assignees the right in perpetuity to use or authorize the use of from to time and at their discretion, her name, voice, photograph, likeness, signature, biographical material and other identification, in any and all media now known or hereafter devised, without compensation for her, her heirs, devisees, executors, administrators or assigns, for the purpose of publicizing, promoting and advertising the sport of tennis, the Tennis Europe, the ITF, the tournament's sanctioning National Association, the tournament and their respective affiliates and events, including, the right to use the same on event posters, photos, programs, merchandise and other materials, and for the televising, broadcasting and filming of the same, and hereby grants and assigns to Tennis Europe, the ITF, the tournament's sanctioning National Association, the tournament and their agents and assignees the right in perpetuity to make, use, show and reproduce, in any and all media now known or hereafter devised, from time to time and at its discretion, motion pictures, still pictures and live, taped or filmed television and other reproduction of him/her during the event for commercial and noncommercial purposes without compensation for him/herself, his/her heirs, devisees, executors, administrators or assigns. Such activities by Tennis Europe, the ITF, the tournament's sanctioning National Association, the tournament or their agents and assignees shall not be identified as or represented to be an endorsement by the player of any product or company.

All players and captains are required to have adequate medical and travel insurance, which is not provided by either Tennis Europe, the host National Association or the local organizer.

The applicant is responsible for taking out a suitable insurance policy which is compliant with local laws and regulations and which insures against claims made for damage to property and for death/injury caused to people at the event for which the applicant is legally liable.


## SECTION V.

## THE DRAW AND SEEDING

## 33. The Draw

Eight Boys and eight Girls teams shall qualify for the Final Rounds of the Competition. According to the number of entries received, the Tennis Europe Junior Committee shall organise Qualifying Rounds.

## 34. SEEDING

(a) When receiving the Nations entries, the Tennis Europe Junior Committee shall first establish provisional seedings and shall make the repartition of the countries, taking into consideration the results of the previous year and the geographical location of the teams.

After the nominations deadline, seeded Nations shall be selected in each qualifying round according to the latest available ranking of the first two players.
(b) For the $16 / 14$ \& Under: There will be four seeded nations in the final stage and two or more in each qualifying zone, depending on the number of teams.

In 4 and 5 team zones, there shall be two seeds.
In 6, 7 and 8 team-zones, there shall be four seeds and shall be positioned as follows:
Number 1 shall be placed on line 1; number 2 on line 8.
Number 3 and 4 shall be drawn by lot. First drawn on line 3 and second on line 6
For the 14 \& 16 \& under: The seeds of the Final Round will be the winners of each Qualifying Round. Their position will be determined by the Ranking of their first two players.

If the final match of a Qualifying Round has to be interrupted due to bad weather or exceptional circumstances, there will be a draw to determine which team will be seeded for the Final Round.

For the 12 \& Under: The teams will be drawn by lot. No seedings shall be made. See appendix 8 .

## 35. THE DRAW

The Draws of the Qualifying and Final Rounds shall be made in public at the venues of the Competition at the same time as the Captain's Meeting the day before the start of the Competition.

Once the draws have been made, there can be no change, unless a player from a seeded team withdraws (only for the 16/14 \& Under) prior to the commencement of the Competition and this adversely affect the seeding, in which case the Referee may request the Committee to adjust the seeding or to make the draw again.

The first round losers will play consolation matches according to the draw backwards.


14 \& 16 \& under: The two teams from each zone qualified for the Final Round should be placed in two different halves of the draw.

12 \& under: For the Final Rounds: Draw the four winners from the qualifying rounds out first placing them on lines $1,4,5 \& 8$ of the draw thereby placing two in each half of the draw. The runners up from each qualifying group could then be drawn ensuring that they are in the opposite half of the draw to their qualifying group winner.

## 36. BYES

If there are byes, they shall be given to the seeded nations in descending order. Further byes will be drawn by lot equally distributed into the draw. For the 12 \& Under byes should be placed in the same order as it would be a seeded draw (first line 2, then 7)

## SECTION VI.

## CONDUCT OF THE COMPETITION

## 37. COMPOSITION OF TIES

Each tie shall consist of two singles and one doubles.

## 38. ORDER OF PLAY

The order of play must be as follows:
Player number 2 vs. Player number 2 Player number 1 vs. Player number 1 Doubles

When a result has been obtained after the second match, the remaining doubles shall still be played to obtain the full score except in exceptional circumstances when the Tournament Committee comprising the Chairman or other representative of the Junior Competitions Committee, the Manager, the Tournament Director and the Referee, may waive this requirement.

For 14 \& 16 \& under: it is mandatory that the latest start time for any match is not later than $9 \mathrm{pm}(21.00 \mathrm{hrs})$. Any match that is not completed by midnight ( 00.00 hrs ) should be interrupted and postponed until the following day. (The Referee can extend the time of play if, in his opinion, the match can be concluded in a reasonable time.)

For 12 \& under: It is mandatory that the latest start time for any match is not later than 20.00 hrs. Any match that is not completed by 23.00 hrs. should be interrupted and postponed until the following day. (The Referee can extend the time of play if, in his opinion, the match can be concluded in a reasonable time.)

A tournament can apply to Tennis Europe for an exemption to the mandatory latest start time at least three months before the entry deadline.


If play is seriously delayed during the week due to adverse weather, the tournament can apply to Tennis Europe to extend the latest start time or modify the match format.

## 39. INTERVAL BETWEEN SINGLES AND DOUBLES

There shall be a break of minimum ten minutes and maximum twenty (20) minutes between the singles matches. There shall be a minimum interval of 30 minutes between the singles and doubles matches unless decided otherwise by the Referee.

## 40. RELOCATION OF DOUBLES MATCH

The Referee has the discretion to transfer a doubles match to another court.

## 41. NOTIFICATION OF SINGLES AND DOUBLES PLAYERS

The Referee shall receive from the Captains, no later than 30 minutes before the scheduled start of play each day, the names of the singles players and the names of the doubles pairing. The doubles pairing may be altered by the Captain within 20 minutes after the Completion of the preceding singles (number 1 vs. number 1) match by formal application to the Referee. Failure to formally advise the Referee of a change to the doubles pairing will result in the forfeit of the doubles match.

## 42. COMPOSITION OF THE DOUBLES PAIRING

Any two (2) members of the team may be nominated by the Captain to play any of the doubles matches.

## 43. ENTITLEMENT TO REST

If a player is called upon to play more than one round in one day, the Referee shall decide his or her entitlement to rest.

## 44. SUBSTITUTIONS

If a player is unable to play his/her match due to health or injury or bereavement following notification of his/her name to the Referee, a substitution may be made by the Captain from the final nominated team, providing the official competition doctor/trainer is in agreement that the player's case is legitimate and the Referee authorises such a substitution. In all cases, the Referee's decision to allow or not allow substitution shall be final.

## 45. ELIGIBILITY TO SIT ON COURT

The Captain of a team, or other member of the team deputising for the Captain, may sit on the court.

## 46. SUSPENSION AND POSTPONEMENT

The Chair Umpire may suspend a match temporarily due to darkness or conditions of the grounds or weather. Any such suspension by the Chair Umpire must be reported immediately to the Referee. The Referee must, however, make all decisions on the postponement of a match until a later day. Unless and until a match is postponed by the Referee, the players, Chair Umpire and all on-court officials must remain ready to resume the match.

Upon suspension of a match, the Chair Umpire shall record the time, point, game and set score, and the name of the server, the sides on which each player was situated and shall collect all balls in use for the match. If suspension is due to darkness it should be after an event number of games have been played in the set in progress or at the end of a set.

There shall be five (5) minutes of warm-up before a match. In the case of a suspended or postponed match, the period of warm-up shall be as follows:

## 47. CODE OF CONDUCT

The Tennis Europe Code of Conduct shall apply (See Appendix 4). Taking into consideration Section II 'Management".

## 48. MEDICALTIME-OUT

If a player retires from a match due to illness or injury, the Referee has the authority, supported by medical advice, to withdraw the player from the other event. Alter-natively, such player may continue in the other event only if a doctor certifies the player's condition has improved to the extent that he/she may function at a sufficient level in his/her next match, whether that be the same day or a later day.

For further clarification please refer to Appendix 5.

## 49. SCORING SYSTEM

Each singles match shall be the best of three Tie-Break sets, unless otherwise approved by Tennis Europe. No rest shall be allowed after the second set.

In Doubles, NoAd scoring shall be used and a 10 point Match Tie-Break will be played if the score reaches one set all. No rest shall be allowed after the second set.

For all singles and doubles matches the No Let Rule shall be in effect.


## 50. PLACEMENT TIES

Placement ties shall be organised for all teams. All Teams must compete in placement ties.

## 51. IDENTIFICATION ON CLOTHING AND EQUIPMENT

The ITF/Tennis Europe Identification on Clothing and Equipment Rule shall apply (See Appendix 4).

## 52. FORMAT OF PLAY

All qualifying rounds are played on three days maximum on principle. The format of play shall be straight knock-out except in the event of only three teams and alternatively in a four-teamszone, where the Round-Robin system can be applied on request of the organisers.

The local organisers must arrange consolation events and placement ties to give first round losers extra playing opportunities. These consolation events shall be held either on a knock-out basis or on a round-robin format. The detailed schedules are explained in the Appendix 8.

## 53. METHOD OF DETERMINING PLACES IN ROUND ROBIN (ALL PLAY ALL) EVENTS

Each tie will consist of three matches, two singles and one doubles.
If teams in a pool finish level at the conclusion of the round robin the order shall be decided as follows:
(a) If two teams are equal, the head to head result of the two teams in the pool match;
(b) If three teams are equal, all match results in the group shall be calculated and the procedures set out in i), ii) and iii) shall apply.
i) Most number of matches won;
ii) \% of sets won of sets played;
iii) \% of games won of games played

## SECTION VII.

PENALTIES

## 54. WITHDRAWALS

Nations whose entries have been accepted into the Competition shall not withdraw. Any team that withdraws its entry later than three (3) months, but before (1) month of the scheduled first day of play of the Qualifying Rounds shall be fined. This fine shall be three times the amount of the entry fee.

Any nation withdrawing their entry within one month of the scheduled first day of play shall be fined four times the amount of the entry fee.

Any team:
(i) not playing all its matches, including consolation or placement ties,
(ii) disqualified for an offence committed,
(iii) withdrawing from the Final Rounds of the Competition after having qualified for them, shall be fined five times the amount of the entry fee.

In case of natural disaster, the Board of Management may resolve by a two-thirds majority that no penalty be imposed.

## 55. DEFAULT IN PAYMENT

Any default in payment in respect of their team's participation in a previous Competition, shall render that nation liable to have its entry refused for any future Competitions until such payment shall have been made in full.

## 56. FAILURE TO ABIDE BY THE RULES AND REGULATIONS

Any competing Nation who fails to conform to these Rules and Regulations may be immediately disqualified and/or shall be liable to have their entry refused for future Competitions until assurances of compliance with the Regulations are given, and subject to any further penalties set out in these Regulations. If a team that otherwise would have qualified for the Final Round of the Competition is disqualified for an offence committed in the Qualifying Round then that team shall be replaced in the Final Round of the Competition by the highest placed team in their Qualifying Round not qualified. For offences that do not justify disqualification, the Board of Management may decide that a fine be imposed.

## SECTION VIII.

ARBITRATION

## 57. SETTLEMENT OF ON-SITE DISPUTES

The Referee shall decide on any on-site disputes or interpretation in accordance with the ITF Rules of Tennis. He or she shall also be the final arbiter for penalties imposed under the Code of Conduct unless the Code provides for an appeal to Tennis Europe for that offence.

The Tournament Committee shall be the final on-site arbiter for any appeal against a decision of the Referee other than on the subjects of the Rules of Tennis or the Code of Conduct.

## 58. FINAL ARBITERS

The Board of Management of Tennis Europe shall be the final arbiters in any dispute, and shall decide any appeals.

## SECTION IX.

## INTERNATIONAL SPONSORSHIP

## 59. SPONSORSHIP REQUIREMENTS

Tennis Europe retains the right to secure sponsors (Title \& International Partners) for Tennis Europe Winter Cups by HEAD, to include sponsorship of all Qualifying \& Final competitions.

Tennis Europe will provide each Host Nation with Promotional Guidelines detailing their rights to secure Domestic Sponsors for the Competition. The Promotional Guidelines will also provide specific instructions regarding the dressing of courts with the identification of the international sponsors.

The Host Nation will also be informed about the services provided by the international sponsors.

## 60. PUBLICITY / PROMOTION \& PLAYER IMAGES

Each player grants and assigns to Tennis Europe, the tournament's sanctioning National Association, the tournament and their agents the right in perpetuity to make, use and show from time to time and at its discretion, motion pictures, still pictures and live, taped or filmed television and other reproduction of him/her during the event and in connection with the promotion of the event without compensation for him/herself, his/her heirs, devisees, executors, administrators or assigns. Such promotional activities by the ITF/Tennis Europe, the tournament's sanctioning National Association, the tournament or their agents shall not be identified as or represented to be an endorsement by the player of any product or company. Notwithstanding the above, it is prohibited for any Tournament Visitor to obtain, transmit, store or distribute any images of players, unless they are the parent or legal guardian of the player, without the express written authorization (which includes permission about how the image(s) will be used) of the parent, legal guardian of the player or ITF/Tennis Europe referee. Any authorised images must be exclusively of tennis matches, practice or tournament activity including the presentation of trophies.


## 61. PLAYERS, CAPTAINS AND OFFICIALS OATH

The taking of a players', captains' and officials' oath is an official part of the Tennis Europe Junior Team Competitions.

Players' Oath:
"In the name of all the competitors I promise that we shall take part in these Tennis Europe Junior Team Competitions, respecting and abiding by the rules which govern them, in the true spirit of sportsmanship, fair play and respect on and off the court. I promise that we shall commit ourselves to a sport without doping and without drugs, for the glory of our sport and the honour of our teams."

Captains' Oath:
"In the name of all Captains, I promise that we shall commit ourselves to ensuring that the spirit of sportsmanship, fair play and respect on and off the court is fully adhered to and upheld for the education of our players and the success of these Tennis Europe Junior Team Competitions."

Officials' Oath:
"In the name of all the officials, I promise that we shall officiate in these Tennis Europe Junior Team Competitions with complete impartiality, respecting and abiding by the rules which govern them, in the true spirit of sportsmanship."

## 62. LATEST START TIME

For 14 \& 16 \& under: it is mandatory that the latest start time for any match is not later than 9 pm ( 21.00 hrs ). Any match that is not completed by midnight ( 00.00 hrs ) should be interrupted and postponed until the following day. (The Referee can extend the time of play if, in his opinion, the match can be concluded in a reasonable time.)

For 12 \& under: It is mandatory that the latest start time for any match is not later than 20.00 hrs. Any match that is not completed by 23.00 hrs. should be interrupted and postponed until the following day. (The Referee can extend the time of play if, in his opinion, the match can be concluded in a reasonable time.)

A tournament can apply to Tennis Europe for an exemption to the mandatory latest start time at least three months before the entry deadline.
If play is seriously delayed during the week due to adverse weather, the tournament can apply to Tennis Europe to extend the latest start time or modify the match format.

## APPENDIX 3

## ITF AGE ELIGIBILITY RULE

## COMPETITION FOR PLAYERS WHO ARE 12 AND UNDER

The following rules set forth eligibility rules and restrictions for competitions and other events (including Games) for players who are 12 and under:
a) There shall be no 11 and under, no 10 and under and no 9 and under (or younger) age category international or regional individual or team competitions or Games.
b) In any calendar year players may only compete in a maximum of ten tournaments for 12 and under events sanctioned by the ITF, or by a Regional Association or by the *USTA and Tennis Canada.
c) Players under the age of 10 shall not be eligible for entry into any international individual tournament, team competition, or Games sanctioned by a Regional Association, a National Association and/or any other national or international organisation. In accordance with the ITF Junior Age Eligibility Rule, the player's age as of the first day of the tournament Main Draw shall be used. Players are allowed to play in a 12 and under event from the year they turn 10 years of age, and have reached their 10th birthday on or before the start of the Singles Main Draw, until the year the player turns 12 years of age.
d) Players are eligible to compete in tournaments for players aged 14 and under sanctioned by the ITF, or by a Regional Association or by the *USTA and Tennis Canada in the year they turn 11 years of age, if they have reached their 11th birthday on or before the start of the Singles Main Draw, until the year the player turns 14 years of age, but participation in such tournaments will count towards the maximum of ten events permitted;
e) Competition for players aged 12 and under organised by a Regional Association must be a team competition;
f) Players aged 12 and under shall not compete in 16 and under international or regional individual or team competitions.
g) There shall be no international or regional rankings for players aged 12 and under;
h) The title 'World Champion'(or any similar title) shall not be awarded to a player winning an event restricted to players who are aged 12 and under;
*Note: For the purpose of this Rule only National Championships in the USA and in Canada count as tournaments covered.


## TEAM COMPETITIONS FOR PLAYERS WHO ARE 14 AND UNDER

The following Rules are applicable to all international team competitions worldwide for players in 14 and under age group events.

Competitors for these competitions in 2018, in 2019, and in 2020, including the ITF World Junior Tennis Competition, must have been born between the following eligible birth years and have reached their 11th birthday on or before the first day of Competition:

2020 2006-2009

## TEAM COMPETITIONS FOR PLAYERS WHO ARE 16 AND UNDER

The following Rules are applicable to all international team competitions worldwide for players in 16 and under age group events. No competitor may participate who is still eligible for 12 and under age group events.

Competitors for these competitions in 2018, in 2019, and in 2020, including the Junior Davis Cup and Junior Fed Cup by BNP Paribas, must have been born between the following eligible birth years and have reached their 13th birthday on or before the first day of Competition:

## APPENDIX 4

## TENNIS EUROPE JUNIOR TEAM COMPETITIONS CODE OF CONDUCT

## A. PURPOSE

Tennis Europe promulgates this Junior Team Competitions Code of Conduct (Code) in order to maintain fair and reasonable standards of conduct by players, team captains and player support team members at international junior team competitions and to protect their respective rights, the rights of the public and the integrity of the Sport of Tennis.

## B. EXCLUSIVE APPLICABILITY

This Code is applicable as stated herein to the Junior Team Competitions, including the Tennis Europe Winter Cups by HEAD. Any reference to players in this Code shall apply to all team members including the captain where appropriate. This Code of Conduct shall be the basis for disciplinary action against any team member or captain in a Tennis Europe Junior Team Competition, except to the extent that disciplinary jurisdiction is established under (i) the Uniform Tennis Anti-Corruption Program; and/or (ii) the Tennis Anti-Doping Programme; and/or (iii) the Tennis Europe Welfare Policy.

A copy of the Code shall be made available on site to each Captain who is responsible for ensuring that all members of his or her team are fully aware of their obligations under this Code.

## C. OFFENCES AND PENALTIES

All teams shall abide by the Rules for entries set forth in the Regulations. Any National Association that withdraws from the Competition, other than as provided for in the Regulations, will be subject to the penalties given in Section VII of these Regulations.

## ARTICLE II: PLAYER ON-SITE OFFENCES

## A. GENERAL

Each player, team captain, team members/extra players, coach, trainer, relatives, parents, guardians or officials attached to either the Host Nation or the participating teams shall, during all matches and at all times while within the precincts of the site (includes the official team hotel) of a Junior Team Competitions event, conduct himself or herself in a professional manner. The provisions hereinafter set forth shall apply while within the precincts of each such site.

## B. PUNCTUALITY

Matches shall be called in accordance with the order of play. Players shall be ready to play when their matches are called. For the purposes of this punctuality rule, the official clock in Junior Team Competitions events shall be the Referee's timepiece.
Any player not ready to play within fifteen (15) minutes after his/her match is called shall be defaulted unless the Referee in his/her sole discretion, after consideration of all relevant circumstances, elects not to declare a default.

## C. DRESS AND EQUIPMENT

Every player and team captain shall dress and present himself/herself for play in a professional manner. Clean and customarily acceptable tennis attire shall be worn.
Any player who violates this Section may be ordered by the Chair Umpire or Referee to change his/her attire or equipment immediately. Failure of a player to comply with such order may result in immediate default. (Tennis Europe reserves the right to interpret the following rules so as to give effect to the intent and purposes of these Regulations)

## 1. Unacceptable attire

Sweatshirts, gym shorts, dress shirts, T-shirts or any other inappropriate attire shall not be worn during a match (including the warm-up).
a. Shoes

Players are required to wear tennis shoes generally accepted as proper tennis attire. Shoes shall not cause damage to the court other than what is expected during the normal course of a match or practice. Damage to a court may be considered as physical or visible, which may include a shoe that leaves mark beyond what is considered acceptable. The Tennis Europe Referee has the authority to determine that a shoe does not meet these criteria and may order the player to change.

## i. Grass Court Shoes

At ITF Junior Team Competition events played on grass court, no shoes other than those with rubber soles, without heels, ribs, studs or coverings, shall be worn by players. Shoes with pimples or studs around the outside of the toes shall not be permitted. The foxing around the toes must be smooth.
The Referee has the authority to determine that a tennis shoe's sole does not conform to such customs and standards and can prohibit its use at TENNIS EUROPE Junior Team Competition events played on grass courts.
ii Clay Court Shoes
Players are required to wear tennis shoes generally accepted for play on clay courts or granular surfaces. The Referee has the authority to determine that a tennis shoe's sole does not conform to such customs and standards and can prohibit its use at TENNIS EUROPE Junior Tour events played on clay courts.
Grass court shoes shall not be worn during a match on clay courts.

## 2. Team Identification

Players and Captains shall be dressed at all times on court in national colours. In addition, clothing shall display the Nation's name on the back of the shirt and may also feature the country flag. Team identification shall be in accordance with the official TENNIS EUROPE Team Identification style guide.

## 3. Doubles Team Identification

In addition to the team identification requirement indicated in Rule 2. Team Identification above, it is emphasized that both members of the team display the nation's name on the back of their shirt and dress in national colours.

## 4. Identification

No identification shall be permitted on a player's or team captain's clothing, products or equipment on court before, during or after a match or at any press conference or tournament ceremony, except as follows (the TENNIS EUROPE reserves the right to interpret the following

rules so as to give effect to the intent and purposes of these Rules):

## a. Shirt, Sweater or Jacket

Sleeves.
One (1) commercial (non-manufacturer's) identification for each sleeve, neither of which exceeds three (3) square inches (19.5 sq.cm), plus one (1) commercial identification of a National Association Team Sponsor on one (1) sleeve, not to exceed three (3) square inches ( 19.5 sq.cm), plus one (1) manufacturer's identification on each sleeve, neither of which exceeds eight (8) square inches ( $52 \mathrm{sq} . \mathrm{cm}$ ) shall be permitted. If written identification is used within this eight (8) square inches ( $52 \mathrm{sq.cm}$ ) area on either or both sleeves, such written identification may not exceed four (4) square inches (26 sq.cm) per sleeve.

## Sleeveless:

The two (2) commercial (non-manufacturer's) identifications permitted on the sleeves above, neither of which shall exceed three (3) square inches ( 19.5 sq.cm), may be placed on the front of the garment.
Front, Back or Collar.
Total of two (2) manufacturer's identifications, neither of which exceeds two (2) square inches (13 sq.cm) or one (1) manufacturer's identification, which does not exceed four (4) square inches ( 26 sq.cm) shall be permitted.

## b. Shorts or Skirts

Two (2) manufacturer's identifications, neither of which exceeds two (2) square inches (13 sq.cm) or one (1) manufacturer's identification which does not exceed four (4) square inches ( 26 sq.cm) shall be permitted. On compression shorts, one (1) manufacturer's identification not to exceed two (2) square inches ( $13 \mathrm{sq.cm}$ ) and which shall be in addition to the manufacturer's identifications on shorts/skirts shall be permitted.
Note: A dress, for the purposes of permissible identification shall be treated as a combination of a skirt and shirt (dividing dress at waist).

## Socks/Shoes

Manufacturer's identifications on each sock and on each shoe shall be permitted. The identifications on the sock(s) on each foot shall be limited to a maximum of two (2) square inches (13 sq.cm).

## Racquet

Manufacturer's identifications on racquet and strings shall be permitted.

## Hat, Headband or Wristband

One (1) manufacturer's identification, without writing, not to exceed two (2) square inches (13 sq.cm) shall be permitted.

Bags, other Equipment or Paraphernalia
Tennis equipment manufacturer's identifications on each item plus two (2) separate commercial identifications on one (1) bag, neither of which exceeds four (4) square inches (26 sq.cm) shall be permitted.

## Another Tennis, Sport or Entertainment Event

h. Notwithstanding anything to the contrary hereinabove set forth the identification by use of the name, emblem, logo, trademark, symbol or other description of any tennis circuit, series of tennis events, tennis exhibition, tennis tournament, any other sport or entertainment event is prohibited on all dress or equipment, unless otherwise approved by the TENNIS EUROPE.


## Non permitted Commercial Identification

No identification shall be permitted on players' or captains' clothing or equipment that promotes/displays betting companies, tobacco products, alcohol products, political activity or other category deemed to be detrimental to the sport of tennis, Tennis Europe or the Tennis Europe Junior Team Competitions.

## General

In the event the utilisation of any of the foregoing permitted commercial identifications would violate any governmental regulation with respect to television, then the same shall be prohibited.
For the purposes of this Rule, the manufacturer means the manufacturer of the clothing or equipment in question.

In addition, the size limitation shall be ascertained by determining the area of the actual patch or other addition to a player's clothing without regard to the colour of the same. In determining area, depending on the shape of the patch or other addition, a circle, triangle or rectangle shall be drawn around the same and the size of the patch for the purpose of this Rule shall be the area within the circumference of the circle or the perimeter of the triangle or rectangle as the case may be. When a solid colour patch is the same colour as the clothing, then in determining the area, the size of the actual patch will be based on the size of the identification.

## 5. Warm-Up Clothing

Players may wear warm-up clothing during the warm-up and during a match provided it complies with the foregoing provisions and provided further that the players obtain approval of the Referee prior to wearing warm-up clothing during a match.
A team's country name on the back of the warm-ups is not considered to be a logo and is legal in any size.
Identification for a National Association Team sponsor on the back of warm-up clothing is permitted and should not exceed three (3) square inches ( $19.5 \mathrm{sq} . \mathrm{cm}$ ) and is permitted to be worn during warm-up only and during any official ceremonies.
6. Taping

No taping over of logos/patches shall be allowed.

## 7. Fines

Violation of the provisions with respect to Team Identification may result in a fine to the relevant National Association to be determined by the ITF Juniors Competitions Committee, such fine not to exceed US $\$ 5,000$.

## D. TIME VIOLATION / DELAY OF GAME

Following the expiration of the warm-up period play shall be continuous and a player shall not unreasonably delay a match for any cause.
A maximum of twenty (20) seconds shall elapse from the moment the ball goes out of play at the end of the point until the time the ball is struck for the first serve of the next point. If such serve is a fault then the second serve must be struck by the server without delay.
When changing ends a maximum of ninety (90) seconds shall elapse from the moment the ball goes out of play at the end of the game until the time the first serve is struck for the next game. If such first serve is a fault the second serve must be struck by the server without delay. However, after the first game of each set and during a tie-break, play shall be continuous and the players shall change ends without a rest period.


At the conclusion of each set, regardless of the score, there shall be a set break of one hundred and twenty (120) seconds from the moment the ball goes out of play at the end of the set until the time the first serve is struck for the next set.
If a set ends after an even number of games, there shall be no change of ends until after the first game of the next set.
The receiver shall play to the reasonable pace of the server and shall be ready to receive within a reasonable time of the server being ready. A Time Violation may be issued prior to the expiration of twenty (20) seconds if the receiver's actions are delaying the reasonable pace of the server.
The first violation of this Section shall be penalised by a Time Violation warning and each subsequent violation shall be penalised by the assessment of one Time Violation point penalty. When a violation is a result of a medical condition, refusal to play or not returning to the court within the allowed time a Code Violation (Delay of Game) penalty shall be assessed in accordance with the Point Penalty Schedule.

## E. AUDIBLE OBSCENITY (AOb)

Players shall not use audible obscenity within the precinct of the tournament site. If such violation occurs during a match (including the warm-up), the player shall be penalised in accordance with the Point Penalty Schedule hereinafter set forth. In circumstances that are flagrant and particularly injurious to the success of a tournament, or are singularly egregious, a single violation of this Section shall also constitute the Major Offence of "Aggravated Behaviour" and shall be subject to the additional penalties hereinafter set forth.
For the purposes of this Rule, audible obscenity is defined as the use of words commonly known and understood to be profane and uttered clearly and loudly enough to be heard by Court Officials or spectators.

## F. VISIBLE OBSCENITY (VOb)

Players shall not make obscene gestures of any kind within the precincts of the tournament site. If such violation occurs during a match (including the warm-up), the player shall be penalised in accordance with the Point Penalty Schedule hereinafter set forth. In circumstances that are flagrant and particularly injurious to the success of a tournament, or are singularly egregious, a single violation of this Section shall also constitute the Major Offence of "Aggravated Behaviour" and shall be subject to the additional penalties hereinafter set forth. For the purposes of this Rule, visible obscenity is defined as the making of signs by a player with his/her hands and/or racquet or balls that commonly have an obscene meaning.

## G. VERBAL ABUSE (VA)

Players shall not at any time verbally abuse any official, opponent, spectator or other person within the precincts of the tournament site. If such violation occurs during a match (including the warm-up), the player shall be penalised in accordance with the Point Penalty Schedule hereinafter set forth. In circumstances that are flagrant and particularly injurious to the success of a tournament, or are singularly egregious, a single violation of this Section shall also constitute the Major Offence of "Aggravated Behaviour" and shall be subject to the additional penalties hereinafter set forth.
For the purposes of this Rule, verbal abuse is defined as a statement about an official, opponent, sponsor, spectator or other person that implies dishonesty or is derogatory, insulting or otherwise abusive.

## H. PHYSICAL ABUSE (PhA)

Players shall not at any time physically abuse any official, opponent, spectator or other person within the precincts of the tournament site. If such violation occurs during a match (including

the warm-up), the player shall be penalised in accordance with the Point Penalty Schedule hereinafter set forth. In circumstances that are flagrant and particularly injurious to the success of a tournament, or are singularly egregious, a single violation of this Section shall also constitute the Major Offence of "Aggravated Behaviour" and shall be subject to the additional penalties hereinafter set forth.
For the purposes of this Rule, physical abuse is the unauthorised touching of a Court Official, opponent, spectator or other person.

## I. ABUSE OF BALLS (BA)

Players shall not violently, dangerously or with anger hit, kick or throw a tennis ball within the precincts of the tournament site except in the reasonable pursuit of a point during a match (including warm-up). If such violation occurs during a match (including the warm-up) the player shall be penalised in accordance with the Point Penalty Schedule hereinafter set forth.
In circumstances that are flagrant and particularly injurious to the success of a tournament, or are singularly egregious, a single violation of this Section shall also constitute the Major Offence of "Aggravated Behaviour" and shall be subject to the additional penalties hereinafter set forth.
For the purposes of this Rule, abuse of balls is defined as intentionally or recklessly hitting a ball out of the enclosure of the court, hitting a ball dangerously or recklessly within the court or hitting a ball with negligent disregard of the consequences.

## J. ABUSE OF RACQUETS OR EQUIPMENT (RA)

Players shall not violently or with anger hit, kick or throw a racquet or other equipment within the precincts of the tournament site. If such violation occurs during a match (including the warm-up), the player shall be penalised in accordance with the Point Penalty Schedule hereinafter set forth.
In circumstances that are flagrant and particularly injurious to the success of a tournament, or are singularly egregious, a single violation of this Section shall also constitute the Major Offence of "Aggravated Behaviour" and shall be subject to the additional penalties hereinafter set forth.
For the purposes of this Rule, abuse of racquets or equipment is defined as intentionally and violently destroying or damaging racquets or equipment or intentionally and violently hitting the net, court, umpire's chair or other fixture during a match out of anger or frustration.

## K. COACHING AND COACHES (CC)

Players shall not receive coaching during a match. Communications of any kind, audible or visible, between a player and a coach other than the team Captain may be construed as coaching. Players shall also prohibit their coaches (1) from using audible obscenity within the precincts of the tournament site, (2) from making obscene gestures of any kind within the precincts of the tournament site, (3) from verbally abusing any official, opponent, spectator or other person within the precincts of the tournament site, (4) from physically abusing any official, opponent, spectator or other person within the precincts of the tournament site and (5) from giving, making, issuing, authorising or endorsing any public statement within the precincts of the tournament site having, or designed to have, an effect prejudicial or detrimental to the best interests of the tournament and/or of the officiating thereof. If such violation occurs during a match (including the warm-up), the player shall be penalised in accordance with the Point Penalty Schedule hereinafter set forth.
In circumstances that are flagrant and particularly injurious to the success of a tournament, or are singularly egregious a single violation of this section shall also constitute the Major Offence of "Aggravated Behaviour" and shall be subject to the additional penalties hereinafter set forth therefore and the Referee may order the Coach to be removed from the site of a match or the

precincts of the tournament site and may declare an immediate default of such player.
For the purposes of this Rule, a "coach" shall also include any representative and/or relative of a player.

## L. UNSPORTSMANLIKE CONDUCT (UnC)

Players shall at all times conduct themselves in a sportsmanlike manner and give due regard to the authority of officials and the rights of opponents, spectators and others. If such violation occurs during a match (including the warm-up), the player shall be penalised in accordance with the Point Penalty Schedule hereinafter set forth. In circumstances that are flagrant and particularly injurious to the success of a tournament, or are singularly egregious, a single violation of this Section shall also constitute the Major Offence of "Aggravated Behaviour" and shall be subject to the additional penalties hereinafter set forth.
For the purposes of this Rule, Unsportsmanlike Conduct is defined as any misconduct by a player that is clearly abusive or detrimental to the Sport, but does not fall within the prohibition of any specific on-site offence contained herein. In addition, unsportsmanlike conduct shall include, but not be limited to, the giving, making, issuing, authorising or endorsing any public statement having, or designed to have, an effect prejudicial or detrimental to the best interests of the tournament and/or the officiating thereof.

## M. BEST EFFORTS (BE)

A player shall use his best efforts to win a match when competing in an TENNIS EUROPE Junior Team Competition event.
For purposes of this Rule, the Referee and/or Chair Umpire shall have the authority to penalise a player in accordance with the Point Penalty Schedule. In circumstances that are flagrant and particularly injurious to the success of the tournament, or are singularly egregious, a single violation of this Section shall also constitute the Major Offence of "Aggravated Behaviour" and shall be subject to the additional penalties hereinafter set forth therefore.

## N. LEAVING THE COURT (LC)

A player shall not leave the court area during a match (including the warm-up) without the permission of the Chair Umpire or Referee. A player who violates this section may be defaulted by the Referee and subjected to the additional penalties for "Failure to Complete a Match" as hereinafter set forth.

## O. FAILURE TO COMPLETE MATCH (FCM)

Any player nominated for any match in the Tie must commence or complete such match unless he is incapacitated by illness, accident or other unavoidable hindrance. A player who violates this section may be defaulted forthwith by the Referee
In circumstances that are flagrant and particularly injurious to the success of a Tie, or are singularly egregious, a single violation of this section may subject him to the additional penalties set forth in these Regulations.

## P. CEREMONIES (Cer)

For the purpose of ceremonies and official functions, under the above section, all teams (only all nominated players and team captains) are required to attend the following functions in appropriate team dress unless reasonably unable to do so, as determined by the Referee:

* The Draw Ceremony
* The Opening Ceremony and the Players', Officials' and Captains' Oath
* The Prize Giving Ceremony

* The Welcome Party
* The Players/Sponsors Party
* The Farewell Party

Violation of this section shall subject the player to suspension by the Tennis Europe Manager of Junior Tennis with respect to the offending incident from play in Tennis Europe Team Competitions and Tennis Europe Junior Tour events organized for a period up to three months.

## Q. MEDIA CONFERENCE (MC)

Unless injured and physically unable to appear, a player or team must attend the postmatch media conference(s) organised immediately or within thirty (30) minutes after the conclusion of each match whether the player or team was the winner or loser, unless such time is extended or otherwise modified by the Referee for good cause.
For purposes of this Rule, media obligations also include but are not limited to post-match and post-draw ceremony interviews with the home and visiting teams national broadcaster and with the journalist from the official Tennis Europe Junior website. Violation of this section shall subject the player to suspension by the Tennis Europe Manager of Junior Tennis with respect to the offending incident from play in Tennis Europe Team Competitions and Tennis Europe Junior Tour events for a period up to three months.

## R. PARTISAN CROWD/SPECTATORS BEHAVIOUR

During Junior Team Competition matches each country must control its supporting spectators so that play is not interrupted or disturbed. In the event that the spectators or any individual spectators supporting a country behave in such a partisan manner that play is unreasonably interrupted or the players at any time are unreasonably provoked and/or intimidated, the Referee shall penalise such country's player in accordance with the following:
FIRST Offence
WARNING
SECOND Offence
POINT PENALTY
THIRD AND EACH SUBSEQUENT Offence
GAME PENALTY
However, after the third Partisan Crowd violation, the Referee shall determine whether each subsequent offence shall constitute a default.
In circumstances that are flagrant and particularly injurious to the success of a Tie, the Referee shall have the authority to declare a default for a single violation of this section.

## S. POINT PENALTY SCHEDULE

The Point Penalty Schedule to be used for violations set forth above is as follows:
FIRST offence
SECOND offence
THIRD AND EACH SUBSEQUENT offence
WARNING

However, after the third Code Violation, the Referee shall determine whether each subsequent offence shall constitute a default.

## T. DEFAULTS

The Referee may declare a default for either a single violation of this Code (Immediate Default) or pursuant to the Point Penalty Schedule set out above. In all cases of default, the decision of the Referee shall be final and unappealable.
Violation of this section shall subject the player to suspension by the Tennis Europe Manager of Junior Tennis with respect to the offending incident from play in Tennis Europe Team Competitions and Tennis Europe Junior Tour events for a period up to three months.
In addition, any player who is defaulted as herein provided may be defaulted from the remainder of the Tie, except when the offending incident involves only a violation of the

Punctuality or Dress and Equipment provisions set forth in Article II B and C，or as a result of a medical condition or when his／her doubles partner commits the Code Violation which causes the default．

However，prior to any default from the remainder of the tie and／or competition，the Referee must use best efforts to obtain the approval of the Tennis Europe Manager of Junior Tennis or his designee．

## U．DOUBLES EVENTS

Warnings／Point Penalties／Game Penalties／Defaults
Warnings，Point Penalties，Game Penalties and／or a Default if assessed for violation of the Code shall be assessed against the team．

## V．DETERMINATION AND PENALTY

The Referee shall make such investigation as is reasonable to determine the facts regarding all Player On－Site offences and upon determining that a violation has occurred shall report all facts in writing to the TENNIS EUROPE Manager of Junior Tennis and give written notice thereof to the player and team captain．

The TENNIS EUROPE Manager of Junior Tennis shall cause an investigation to be made of all facts concerning any alleged Major Offence and shall provide written notice of such investigation to the player or related person involved；the player shall be given at least ten（10） days to provide to the TENNIS EUROPE Manager of Junior Tennis，directly or through counsel，such evidence as the player or related person deems to be relevant to the investigation．Upon the completion of his investigation the TENNIS EUROPE Manager of Junior Tennis shall determine the innocence or guilt of the player involved，and，in the latter case，shall state in writing the facts as found by him，his conclusions and his decision fixing the penalty to be imposed．A copy of the decision shall be promptly delivered to the player and to the Juniors Committee．

## W．Discretionary Review

Any player or related person found to have committed a Player On Site－Offence，except a Default，may petition the Juniors Committee for discretionary review of the determination and penalty of the TENNIS EUROPE Manager of Junior Tennis．The petition shall be in writing and must be filed with the TENNIS EUROPE Manager of Junior Tennis within ten（10）days after notice of the violation is mailed to the player or related person．The TENNIS EUROPE Manager of Junior Tennis shall thereafter promptly forward said petition to the Juniors Committee．Said petition shall state in detail the basis for such appeal．Within ten（10）days thereafter the Juniors Committee shall designate a time and place for the hearing of such appeal and shall so notify the player or related person and the TENNIS EUROPE Manager of Junior Tennis．At such hearing the player or related person and the TENNIS EUROPE Manager of Junior Tennis shall present to the Juniors Committee the relevant evidence on the matter．The Juniors Committee may affirm，reverse，or modify the decision of the TENNIS EUROPE Manager of Junior Tennis on appeal．
If the appeal is decided against the player or related person，then the Juniors Committee shall tax the reasonable costs of the appeal against the player or related person，which costs shall include，but not be limited to，the reasonable travel and living expenses incurred by all witnesses and members of the Juniors Committee with respect thereto，if the same is not at a regular scheduled meeting of the Committee

## ARTICLE III：UNIFORM TENNIS ANTI－CORRUPTION PROGRAM


A. Introduction

The purpose of the Uniform Tennis Anti-Corruption Program is to (i) maintain the integrity of tennis, (ii) protect against any efforts to impact improperly the results of any match and (iii) establish a uniform rule and consistent scheme of enforcement and sanctions applicable to all professional tennis Events and to all Governing Bodies.

## B. Definitions

"AHO" refers to an Anti-Corruption Hearing Officer.
"ATP" refers to the ATP Tour, Inc.
"CAS" refers to the Court of Arbitration for Sport.
"Consideration" refers to anything of value except for money.
"Corruption Offense" refers to any offense described in Section D or E of this Program.
"Covered Person" refers to any Player, Related Person, or Tournament Support Personnel.
"Decision" refers to a decision of an AHO regarding the commission of a Corruption Offense.
"Demand" refers to a written demand for information issued by the TIU to any Covered Person.
"Director" refers to the Director of the TIU.
"Event" refers to all professional tennis matches and other tennis competitions, whether men's or women's, including, without limitation, all tournaments organized, sanctioned or recognized by any of the Governing Bodies.
"Governing Bodies" refers to the ATP, the TENNIS EUROPE, the WTA and the GSC.
"GSC" refers to the Grand Slam Committee.
"Hearing" refers to a hearing before an AHO in accordance with Section G of this Program.
"Information in the public domain" refers to information which has been published or is a matter of public record or can be readily acquired by an interested member of the public and/or information which has been disclosed according to the rules or regulations governing a particular event.
"Inside Information" refers to information about the likely participation or likely performance of a Player in an Event or concerning the weather, court conditions, status, outcome or any other aspect of an Event which is known by a Covered Person and is not information in the public domain.
"ITF" refers to the International Tennis Federation.
"Notice" refers to written Notice sent by the PTIO to a Covered Person alleged to have committed a Corruption Offense.

"Player" refers to any player who enters or participates in any competition, Event or activity organized or sanctioned by any Governing Body.
"Program" refers to this Uniform Tennis Anti-Corruption Program.
"Provisional Suspension" refers to a period of ineligibility imposed by an AHO before a full hearing has taken place.
"PTIO" refers to the Professional Tennis Integrity Officer appointed by each Governing Body.
"Related Person" refers to any coach, trainer, therapist, physician, management representative, agent, family member, tournament guest, business associate or other affiliate or associate of any Player, or any other person who receives accreditation at an Event at the request of the Player or any other Related Person.
"Substantial Assistance" refers to assistance given by a Covered Person to the PTIO or TIU that results in the discovery or establishing of a corruption offense by another Covered Person.
"TIB" refers to the Tennis Integrity Board.
"TIU" refers to the Tennis Integrity Unit.
"Tournament Support Personnel" refers to any tournament director, owner, operator, employee, agent, contractor or any similarly situated person at any Event and any other person who receives accreditation at an Event at the request of Tournament Support Personnel.
"Wager" refers to a wager of money or Consideration or any other form of financial speculation.
"WTA" refers to the WTA Tour, Inc.

## C. Covered Players, Persons and Events

1. All Players, Related Persons, and Tournament Support Personnel shall be bound by and shall comply with all of the provisions of this Program and shall be deemed to accept all terms set out herein as well as the Tennis Integrity Unit Privacy Policy which can be found at www.tennisintegrityunit.com.
2. It is the responsibility of each Player, Related Person and Tournament Support Personnel to acquaint himself or herself with all of the provisions of this Program. Further, each Player shall have a duty to inform Related Persons with whom they are connected of all of the provisions of this Program and shall instruct Related Persons to comply with the Program.

## D. Offenses

Commission of any offense set forth in Section D or E of this Program including a violation of the Reporting Obligations or any other violation of the provisions of this Program shall constitute a Corruption Offense for all purposes of this Program.

1. Corruption Offenses.

a. No Covered Person shall, directly or indirectly, wager or attempt to wager on the outcome or any other aspect of any Event or any other tennis competition.
b. No Covered Person shall, directly or indirectly, solicit or facilitate any other person to wager on the outcome or any other aspect of any Event or any other tennis competition. For the avoidance of doubt, to solicit or facilitate to wager shall include, but not be limited to: display of live tennis betting odds on a Covered Person website; writing articles for a tennis betting publication or website; conducting personal appearances for a tennis betting company; and appearing in commercials encouraging others to bet on tennis.
c. No Covered Person shall, directly or indirectly, solicit or accept any money, benefit or Consideration for the provision of an accreditation to an Event (i) for the purpose of facilitating a commission of a Corruption Offense; or (ii) which leads, directly or indirectly, to the commission of a Corruption Offense.
d. No Covered Person shall, directly or indirectly, contrive or attempt to contrive the outcome or any other aspect of any Event.
e. No Covered Person shall, directly or indirectly, solicit or facilitate any Player to not use his or her best efforts in any Event.
f. No Covered Person shall, directly or indirectly, solicit or accept any money, benefit or Consideration with the intention of negatively influencing a Player's best efforts in any Event.
g. No Covered Person shall, directly or indirectly, offer or provide any money, benefit or Consideration to any other Covered Person with the intention of negatively influencing a Player's best efforts in any Event.
h. No Covered Person shall, directly or indirectly, solicit or accept any money, benefit or Consideration, for the provision of any Inside Information.
i. No Covered Person shall, directly or indirectly, offer or provide any money, benefit or Consideration to any other Covered Person for the provision of any Inside Information.
j. No Covered Person shall, directly or indirectly, offer or provide any money, benefit or Consideration to any Tournament Support Personnel in exchange for any information or benefit relating to a tournament.
k. No Covered Person may be employed or otherwise engaged by a company which accepts wagers on Events.

## 2. Reporting Obligation.

a. Players.
i. In the event any Player is approached by any person who offers or provides any type of money, benefit or Consideration to a Player to (i) influence the outcome or any other aspect of any Event, or (ii) provide Inside Information, it shall be the Player's obligation to report such incident to the TIU as soon as possible.

ii. In the event any Player knows or suspects that any other Covered Person or other individual has committed a Corruption Offense, it shall be the Player's obligation to report such knowledge or suspicion to the TIU as soon as possible.
iii. If any Player knows or suspects that any Covered Person has been involved in an incident described in Section D.2.b. below, a Player shall be obligated to report such knowledge or suspicion to the TIU as soon as possible.
iv. A Player shall have a continuing obligation to report any new knowledge or suspicion regarding any Corruption Offense, even if the Player's prior knowledge or suspicion has already been reported.

## b. Related Persons and Tournament Support Personnel.

i. In the event any Related Person or Tournament Support Person is approached by any person who offers or provides any type of money, benefit or Consideration to a Related Person or Tournament Support Person to (i) influence or attempt to influence the outcome of any aspect of any Event, or (ii) provide Inside Information, it shall be the Related Person's or Tournament Support Person's obligation to report such incident to the TIU as soon as possible.
ii. In the event any Related Person or Tournament Support Person knows or suspects that any Covered Person or other individual has committed a Corruption Offense, it shall be the Related Person's or Tournament Support Person's obligation to report such knowledge or suspicion to the TIU as soon as possible.
c. For the avoidance of doubt, (i) a failure of the Reporting Obligation by any Covered Person; and/or (ii) a failure of the duty to cooperate under Section F. 2 shall constitute a Corruption Offense for all purposes of the Program.

## E. Additional Matters

1. Each Player shall be responsible for any Corruption Offense committed by any Covered Person if such Player either (i) had knowledge of a Corruption Offense and failed to report such knowledge pursuant to the reporting obligations set forth in Section D.2. above or (ii) assisted the commission of a Corruption Offense. In such event, the AHO shall have the right to impose sanctions on the Player to the same extent as if the Player had committed the Corruption Offense.
2. For a Corruption Offense to be committed, it is sufficient that an offer or solicitation was made, regardless of whether any money, benefit or Consideration was actually paid or received.
3. Evidence of a Player's lack of efforts or poor performance during an Event may be offered to support allegations that a Covered Person committed a Corruption Offense, but the absence of such evidence shall not preclude a Covered Person from being sanctioned for a Corruption Offense.
4. A valid defense may be made to a charge of a Corruption Offense if the person alleged to have committed the Corruption Offense (a) promptly reports such conduct to the TIU and (b) demonstrates that such conduct was the result of an honest and reasonable belief that there

was a significant threat to the life or safety of such person or any member of such person's family.
F. Investigation and Procedure

## 1. Anti-Corruption Hearing Officer.

a. The TIB shall appoint one or more independent AHOs, who shall be responsible for (i) determining whether Corruption Offenses have been committed, and (ii) fixing the sanctions for any Corruption Offense found to have been committed.
b. An AHO shall serve a term of two years, which may thereafter be renewed in the discretion of the TIB. If an AHO becomes unable to serve, a new AHO may be appointed for a full twoyear term pursuant to this provision.
2. Investigations.
a. The TIU shall have the right to conduct an initial interview and follow-up interviews, if necessary as determined solely by the TIU, with any Covered Person in furtherance of investigating the possibility of a commission of a Corruption Offense.
i. The date and time of all interviews shall be determined by the TIU, giving reasonable allowances for Covered Persons' tournament and travel schedules.
ii. The Covered Person shall have the right to have counsel attend the interview(s).
iii. The interview shall be recorded. The recorded interviews shall be used for transcription and evidentiary purposes and thereafter shall be retained by the TIU for a minimum of 3 years in a secure place.
iv. The Covered Person shall have the right to request an interpreter, and the cost shall be borne by the TIU.
v. Transcripts of the interview shall be provided to the Covered Person, upon request, within a reasonable period of time following the conclusion of the interview.
b. All Covered Persons must cooperate fully with investigations conducted by the TIU including giving evidence at hearings, if requested. No Covered Person shall tamper with or destroy any evidence or other information related to any Corruption Offense.
c. If the TIU believes that a Covered Person may have committed a Corruption Offense, the TIU may make a Demand to any Covered Person to furnish to the TIU any information regarding the alleged Corruption Offense, including, without limitation, (i) records relating to the alleged Corruption Offense (including, without limitation, itemized telephone billing statements, text of SMS messages received and sent, banking statements, Internet service records, computers, hard drives and other electronic information storage devices), and (ii) a written statement setting forth the facts and circumstances with respect to the alleged Corruption Offense. The Covered Person shall furnish such information within seven business days of the making of such Demand, or within such other time as may be set by the TIU. Any information furnished to the TIU shall be (i) kept confidential except when it becomes necessary to disclose such information in furtherance of the prosecution of a Corruption Offense, or when such

information is reported to administrative, professional, or judicial authorities pursuant to an investigation or prosecution of non sporting laws or regulations and (ii) used solely for the purposes of the investigation and prosecution of a Corruption Offense.
d. By participating in any Event, or accepting accreditation at any Event, a Covered Person contractually agrees to waive and forfeit any rights, defenses, and privileges provided by any law in any jurisdiction to withhold information requested by the TIU or the AHO. If a Covered Person fails to produce such information, the AHO may rule a Player ineligible to compete, and deny a Covered Person credentials and access to Events, pending compliance with the Demand.
e. If a PTIO concludes that a Corruption Offense may have been committed, the PTIO shall refer the matter and send the evidence to the AHO, and the matter shall proceed to a Hearing before the AHO in accordance with Section G of this Program.
3. Each Covered Person shall be determined to be immediately contactable at the most current postal address provided to a Governing Body. Any Notice delivered hereunder to a Covered Person at such address, shall be deemed to have been received by the Covered Person on date of delivery to such address in the confirmation of delivery provided by the courier service company. At its discretion, as an alternative to or in conjunction with the courier delivery, any other method of secure and confidential communication may be used, including, but not limited to hand delivery, facsimile or e-mail, provided that the burden of proving receipt via such alternative methods shall be on the sending party.

## G. Due Process

## 1. Commencement of Proceedings.

a. When the PTIO refers a matter to the AHO pursuant to Section F.2.e, the PTIO shall send a Notice to each Covered Person alleged to have committed a Corruption Offense, with a copy to the AHO, setting out the following:
i. the Corruption Offense(s) alleged to have been committed, including the specific Section(s) of this Program alleged to have been infringed;
ii. the facts upon which such allegations are based;
iii. the potential sanctions prescribed under this Program for such Corruption Offense(s); and
iv. the Covered Person's entitlement to have the matter determined by the AHO at a Hearing.
b. The Notice shall also specify that, if the Covered Person wishes to dispute the PTIO's allegations, the Covered Person must submit a written request to the AHO for a Hearing so that it is received as soon as possible, but in any event within fourteen business days of the date of the receipt of Notice as defined in Article F.3.
c. A Covered Person shall direct any response to a Notice to the AHO with a copy to the PTIO and may respond in one of the following ways:
i. To admit the Corruption Offense and accede to the imposition of sanctions, in which case no hearing shall be conducted and the AHO shall promptly issue a Decision confirming the

commission of the Corruption Offense(s) alleged in the Notice and ordering the imposition of sanctions, which shall be determined by the AHO after requesting and giving due consideration to a written submission from the PTIO on the recommended sanction.
ii. To deny the Corruption Offense and to have the AHO determine the charge, and if the charge is upheld, the sanctions, at a hearing conducted in accordance with Section G.2.
iii. To admit that he or she has committed the Corruption Offense(s) specified in the Notice, but to dispute and/or seek to mitigate the sanctions specified in the Notice. Either a request for hearing or a written submission solely on the issue of the sanction must be submitted simultaneously with the Covered Person's response to the Notice. If a hearing is requested, it shall be conducted in accordance with Section G.2. If no hearing is requested, the AHO shall promptly issue a Decision confirming the commission of the Corruption Offense(s) specified in the Notice and ordering the imposition of sanctions, after giving due consideration to the Covered Person's written submission (if any) and any response submitted by the PTIO.
d. If the Covered Person fails to file a written request for a hearing by the deadline set out in Section G. 1. b, he or she shall be deemed:
to have waived his or her entitlement to a hearing;
to have admitted that he or she has committed the Corruption Offense(s) specified in the Notice;
to have acceded to the potential sanctions specified in the Notice; and,
the AHO shall promptly issue a Decision confirming the commission of the Corruption Offense(s) alleged in the Notice and ordering the imposition of sanctions, (after requesting and giving due consideration to a written submission from the PTIO on the recommended sanction).
e. When a matter has been referred to the AHO pursuant to Section F.2.e, the PTIO may make an application to the AHO for a provisional suspension of the Covered Person if the PTIO determines that: (i) there is a substantial likelihood that the Covered Person has committed a Corruption Offense punishable by permanent ineligibility; (ii) in the absence of a provisional suspension, the integrity of tennis would be seriously undermined; and (iii) the harm resulting from the absence of a provisional suspension outweighs the hardship of the provisional suspension on the Covered Person.

The Covered Person shall be notified that the PTIO has made an application for a provisional suspension and shall be given the opportunity to make submissions in response to the application. The AHO shall decide the appropriate procedure for determining the provisional suspension application, including whether the application should be determined on the papers or whether to convene a hearing. The Covered Person shall be afforded a fair process, including a reasonable opportunity to present his/her case and supporting evidence.
ii. The provisions of Section H.1.c regarding the effect of a sanction of a period of ineligibility shall apply to a Covered Person who is serving a provisional suspension. The provisional suspension shall take effect from the date on which the AHO's decision regarding the application for the provisional suspension is deemed to have been received by the Covered Person.

iii. In the event that the Hearing is not commenced within sixty days from the date on which the Covered Person requested a Hearing, the Covered Person may apply to the AHO for the provisional suspension to be lifted. The provisions of Section G.1.e.(i) and (ii) shall apply to any such application by the Covered Person.
f. If, for any reason, the AHO is or becomes unwilling or unable to hear the case, then the AHO may request that the TIP appoint a substitute or successor AHO for such matter in accordance with Section F. 1.
g. In the event a Covered Person requests a hearing under Section G.1.c.ii or G.2.c.iii, thereafter, but no more than twenty business days after the date of the Notice or request for Hearing if received, the AHO shall convene a meeting or telephone conference with the PTIO and/or its legal representatives, the Covered Person to whom the Notice was sent and his or her legal representatives (if any), to take jurisdiction formally over the matter and to address any pre-Hearing issues. The non-attendance of the Covered Person or his or her representatives at the meeting, after proper notice of the meeting has been provided, shall not prevent the AHO from proceeding with the meeting in the absence of the Covered Person, whether or not any written submissions are made on behalf of the Covered Person. In the meeting the AHO shall:
i. determine the date(s) (which must be at least twenty business days after the meeting, unless the parties consent to a shorter period) upon which the Hearing shall be held. Subject to the foregoing sentence, the Hearing shall be commenced as soon as practicable after the Notice is sent, and ordinarily within sixty days of the date that the Covered Person requests a Hearing. The Hearing shall be completed expeditiously;
ii. establish dates reasonably in advance of the date of the Hearing at which:

1. the Covered Person shall submit a brief with argument on all issues that he or she wishes to raise at the Hearing;
2. the PTIO shall submit an answering brief, addressing the arguments of the Covered Person and setting out argument on the issues that the PTIO wishes to raise at the Hearing;
3. the Covered Person may submit a reply brief, responding to the PTIO's answer brief; and
the Covered Person and the PTIO shall exchange witness lists (with each witness's address, telephone number and a summary of the subject areas of the witness's anticipated testimony) and copies of the exhibits that they intend to introduce at the Hearing; and
iii. make such order as the AHO shall deem appropriate in relation to the production of relevant documents or other materials between the parties.
h. The AHO may, at any time prior to issuing a Decision, request that an additional investigation be conducted into any matter reasonably related to the alleged Corruption Offense. If the AHO requests such an additional investigation, the TIU shall conduct the investigation in accordance with the AHO's directions and shall report the findings of that investigation to the AHO and the Covered Person implicated in the alleged Corruption Offense at least ten days prior to the Hearing. If the Covered Person wishes to object to, or raise any

issues in connection with, such additional investigation, he or she may do so by written submission to the AHO.
4. Conduct of Hearings.
a. Hearings shall be conducted on a confidential basis. Unless the AHO orders otherwise for good cause shown by a party, each Hearing shall take place in either Miami, Florida, USA or London, England, as determined by the AHO.
b. The Covered Person shall have the right (i) to be present and to be heard at the Hearing and (ii) to be represented at the Hearing, at his or her expense, by legal counsel. The Covered Person may choose not to appear at the Hearing, but rather to provide a written submission for consideration by the AHO, in which case the AHO shall take such submission into account in making his or her Decision. However, the non-attendance of the Covered Person or his or her representative at the Hearing, after proper notice of the Hearing has been provided, shall not prevent the AHO from proceeding with the Hearing in his or her absence, whether or not any written submissions are made on his or her behalf.
c. The procedures followed at the Hearing shall be at the discretion of the AHO, provided that the Hearing shall be conducted in a fair manner with a reasonable opportunity for each party to present evidence (including the right to call and to question witnesses), address the AHO and present his, her or its case.
d. The PTIO shall make arrangements to have the Hearing recorded or transcribed at the PTIO's expense. If requested by the Covered Person, the PTIO shall also arrange for an interpreter to attend the Hearing, at the PTIO's expense.
e. Witness testimony presented in person or by video conference is acceptable.
f. The TIB as well as PTIO members shall be permitted to attend all hearings, in person or by audio or video conference.
5. Burdens and Standards of Proof.
a. The PTIO (which may be represented by legal counsel at the Hearing) shall have the burden of establishing that a Corruption Offense has been committed. The standard of proof shall be whether the PTIO has established the commission of the alleged Corruption Offense by a preponderance of the evidence.
b. Where this Program places the burden of proof upon the Covered Person alleged to have committed a Corruption Offense to rebut a presumption or establish facts or circumstances, the standard of proof shall be by a preponderance of the evidence.
c. The AHO shall not be bound by any jurisdiction's judicial rules governing the admissibility of evidence. Instead, facts relating to a Corruption Offense may be established by any reliable means, as determined in the sole discretion of the AHO.
6. Decisions.
a. Once the parties have made their submissions, the AHO shall determine whether a


Corruption Offense has been committed. Where Section H of this Program specifies a range of possible sanctions for the Corruption Offense found to have been committed, the AHO shall also fix the sanction within that range, after considering any submissions on the subject that the parties may wish to make.
b. The AHO shall issue a Decision in writing as soon as possible after the conclusion of the Hearing. Such Decision will be sent to the parties and shall set out and explain:
i. the AHO's findings as to what Corruption Offenses, if any, have been committed;
ii. the sanctions applicable, if any, as a result of such findings; and
iii. the rights of appeal applicable pursuant to Section I of this Program.
c. The TIU shall pay all costs and expenses of the AHO and of staging the Hearing. The AHO shall not have the power to award costs or make any costs order against a Covered Person or the PTIO. Each party shall bear its own costs, legal, expert and otherwise.
d. Subject only to the rights of appeal under Section I of this Program, the AHO's Decision shall be the full, final and complete disposition of the matter and will be binding on all parties. If the AHO determines that a Corruption Offense has been committed, the TIB will publicly report the Decision.

## H. Sanctions

1. The penalty for any Corruption Offense shall be determined by the AHO in accordance with the procedures set forth in Section G, and may include:
a. With respect to any Player, (i) a fine of up to $\$ 250,000$ plus an amount equal to the value of any winnings or other amounts received by such Covered Person in connection with any Corruption Offense, (ii) ineligibility for participation in any event organized or sanctioned by any Governing Body for a period of up to three years, and (iii) with respect to any violation of Section D.1, clauses (d)-(j) and Section D.2., ineligibility for participation in any event organized or sanctioned by any Governing Body for a maximum period of permanent ineligibility.
b. With respect to any Related Person or Tournament Support Person, (i) a fine of up to $\$ 250,000$ plus an amount equal to the value of any winnings or other amounts received by such Covered Person in connection with any Corruption Offense; (ii) suspension of credentials and access to any Event organized, sanctioned or recognized by any Governing Body for a period of not less than one year, and (iii) with respect to any violation of clauses (c)-(i) of Section D.1., suspension of credentials and access to any Event organized, sanctioned or recognized by any Governing Body for a maximum period of permanent revocation of such credentials and access.
c. No Player who has been declared ineligible may, during the period of ineligibility, participate in any capacity in any Event (other than authorized anti-gambling or anti-corruption education or rehabilitation programs) organized or sanctioned by any Governing Body. Without limiting the generality of the foregoing, such Player shall not be given accreditation for, or otherwise granted access to, any competition or event to which access is controlled by any Governing Body, nor shall the Player be credited with any points for any competition played during the period of ineligibility.

2. The TIU may report information regarding an investigation to the TIB and the PTIOs at any time.
3. The TIB may report Corruption Offenses that also violate non-sporting laws and regulations to the competent administrative, professional or judicial authorities.
4. If any Covered Person commits a Corruption Offense under this program during a period of ineligibility, it shall be treated as a separate Corruption Offense under this Program.

Substantial Assistance. The AHO may reduce any period of ineligibility, either at the time of the original decision or subsequently (by reconvening), if the Covered Person has provided substantial assistance to the PTIO or the TIU that results in the discovery or establishing of a corruption offense by another Covered Person. Upon application by the Covered Person pursuant to this provision, the AHO shall establish an appropriate procedure for consideration of the application, including the opportunity for the Covered Person and the PTIO to make submissions regarding the application. The AHO has complete discretion in consideration an application for reduction of a penalty under this provision.

## I. Appeals

1. Any Decision (i) that a Corruption Offense has been committed, (ii) that no Corruption Offense has been committed, (iii) imposing sanctions for a Corruption Offense, or (iv) that the AHO lacks jurisdiction to rule on an alleged Corruption Offense or its sanctions, may be appealed exclusively to CAS in accordance with CAS's Code of Sports-Related Arbitration and the special provisions applicable to the Appeal Arbitration Proceedings, by either the Covered Person who is the subject of the Decision being appealed, or the TIB.
2. Any Decision appealed to CAS shall remain in effect while under appeal unless CAS orders otherwise.
3. The deadline for filing an appeal with CAS shall be twenty business days from the date of receipt of the Decision by the appealing party.
4. The decision of CAS shall be final, non-reviewable, non-appealable and enforceable. No claim, arbitration, lawsuit or litigation concerning the dispute shall be brought in any other court or tribunal.

## J. Conditions of Reinstatement

1. Once a Covered Person's period of ineligibility or suspension has expired and the Covered Person has paid all fines and/or prize money forfeitures, the Covered Person will become automatically eligible and no application by the Covered Person for reinstatement will be necessary.
2. All fines and/or prize money forfeitures imposed on players hereunder must be paid within thirty (30) days following the later of the receipt of an AHO decision or, if appealed to CAS, the receipt of the CAS decision. If not paid within the prescribed timeframe, the player shall be ineligible for participation in any event organized or sanctioned by any Governing Body until such time as the fine and/or prize money forfeitures have been paid in full. The AHO and the PTIO shall have the discretion to establish an instalment plan for payment of any fines and/or prize money forfeitures. For the avoidance of doubt, the schedule of payments pursuant to such plan may extend beyond any period of ineligibility; however, a default in payment under such plan shall automatically trigger a period of ineligibility until such default is cured.

K. General
3. No action may be commenced under this Program against any Covered Person for any Corruption Offense unless such action is commenced within either (i) eight years from the date that the Corruption Offense allegedly occurred or (ii) two years after the discovery of such alleged Corruption Offense, whichever is later.
4. Section headings within this Program are for the purpose of guidance only and do not form part of the Program itself. Nor do they inform or affect the language of the provisions to which they refer.
5. This Program shall be governed in all respects (including, but not limited to, matters concerning the arbitrability of disputes) by the laws of the State of Florida, without reference to conflict of laws principles.
6. In the event any provision of this Program is determined invalid or unenforceable, the remaining provisions shall not be affected. This Program shall not fail because any part of this Program is held invalid.
7. Except as otherwise stated herein, failure to exercise or enforce any right conferred by the Program shall not be deemed to be a waiver of any such right nor operate so as to bar the exercise or enforcement thereof or of any other right on any other occasion.
8. This Program is applicable prospectively to Corruption Offenses occurring on or after the date that this Program becomes effective. Corruption Offenses occurring before the effective date of this Program are governed by the former rules of the Governing Bodies which were applicable on the date that such Corruption Offense occurred.
9. Except as otherwise agreed to by the parties, all filings, Decisions, Hearings and appeals shall be issued or conducted in English.

## ARTICLE IV: PLAYER MAJOR OFFENCES

## A. Aggravated Behaviour

No player or Related Person at any TENNIS EUROPE Junior Team Competition event shall engage in "Aggravated Behaviour" which is defined as follows:

1. One or more incidents of behaviour designated in this Code as constituting "Aggravated Behaviour".
2. One incident of behaviour that is flagrant and particularly injurious to the success of an TENNIS EUROPE Junior Team Competition event, or is singularly egregious.
3. A series of two (2) or more violations of this Code within a twelve (12) month period which singularly do not constitute "Aggravated Behaviour", but when viewed together establish a pattern of conduct that is collectively egregious and is detrimental or injurious to the TENNIS EUROPE Junior Team Competition.
Violation of this section by a player, directly or indirectly through a Related Person or others, shall subject the player to a maximum penalty of permanent suspension from play in TENNIS EUROPE Junior Team Competitions, TENNIS EUROPE Junior Circuit tournaments and Regional Circuit tournaments organized by any Regional Association.

Any player or Related Person who, directly or indirectly, offers or provides or receives any

money, benefit or consideration to or from any other covered person or third party in exchange for access and/or accreditation to the tournament site shall be deemed to have engaged in Aggravated Behaviour and be in violation of this section.

Violation of this Section shall subject a Related Person to a maximum penalty of permanent denial of access to all TENNIS EUROPE Junior Team Competitions, TENNIS EUROPE Junior Circuit tournaments and Regional Circuit tournaments organized by any Regional Association.

## B. Conduct contrary to the integrity of the game

No player or Related Person shall engage in conduct contrary to the integrity of the Game of Tennis. If a player is convicted of a violation of a criminal or civil law of any country, the punishment of which includes possible imprisonment for more than one year, he/she may be deemed by virtue of such conviction to have engaged in conduct contrary to the integrity of the Game of Tennis and the TENNIS EUROPE Manager of Juniors Tennis may provisionally suspend such player from further participation in TENNIS EUROPE Junior Team Competitions pending a final determination in Section C. In addition, if a player has at any time behaved in a manner severely damaging to the reputation of the sport, he/she may be deemed by virtue of such behaviour to have engaged in conduct contrary to the integrity of the Game of Tennis and be in violation of this section.
Violation of this section by a player, directly or indirectly through a Related Person or others, shall subject the player to a maximum penalty of permanent suspension from play in TENNIS EUROPE Junior Team Competitions, TENNIS EUROPE Junior Circuit tournaments and Regional Circuit tournaments organized by any Regional Association.

Violation of this Section shall subject a Related Person to a maximum penalty of permanent denial of access to all TENNIS EUROPE Junior Team Competitions, TENNIS EUROPE Junior Circuit tournaments and Regional Circuit tournaments organized by any Regional Association.

## C. DETERMINATION AND PENALTY

The TENNIS EUROPE Manager of Junior Tennis shall cause an investigation to be made of all facts concerning any alleged Major Offence and shall provide written notice of such investigation to the player involved; the player or related person shall be given at least ten (10) days to provide to the TENNIS EUROPE Manager of Junior Tennis, directly or through counsel, such evidence as the player or related person deems to be relevant to the investigation. The TENNIS EUROPE Manager of Junior Tennis may provisionally suspend such player from further participating on the TENNIS EUROPE Junior Circuit pending a final determination. Upon the completion of his investigation the TENNIS EUROPE Manager of Junior Tennis shall determine the innocence or guilt of the player or related person involved, and, in the latter case, shall state in writing the facts as found by him, his conclusions and his decision fixing the penalty to be imposed. A copy of the decision shall be promptly delivered to the player and to the Juniors Committee.

## D. Discretionary Review

Any player or Related Person found to have committed a Player Major Offence may petition the Juniors Committee for discretionary review of the determination and penalty of the TENNIS EUROPE Manager of Junior Tennis. The petition shall be in writing and must be filed with the TENNIS EUROPE Manager of Junior Tennis within ten (10) days after notice of the violation is mailed to the player or related person. The TENNIS EUROPE Manager of Junior Tennis shall thereafter promptly forward said petition to the Juniors Committee. Said petition shall state in detail the basis for such appeal. Within thirty (30) days thereafter the Juniors Committee shall designate a time and place for the hearing of such appeal and shall so notify the player or
related person and the TENNIS EUROPE Manager of Junior Tennis. At such hearing the player or related person and the TENNIS EUROPE Manager of Junior Tennis shall present to the Juniors Committee the relevant evidence on the matter. The Juniors Committee may affirm, reverse, or modify the decision of the TENNIS EUROPE Manager of Junior Tennis on appeal. If the appeal is decided against the player or related person, then the Juniors Committee shall tax the reasonable costs of the appeal against the player, which costs shall include, but not be limited to, the reasonable travel and living expenses incurred by all witnesses and members of the Juniors Committee with respect thereto, if the same is not at a regular scheduled meeting of the Committee.

## ARTICLE V: Medical Control - Anti-Doping Policy

Any Player, Captain, Player Support Team Member or other Person who participates in the TENNIS EUROPE Junior Team Competitions shall be bound by and shall comply with all of the provisions of the ITF Tennis Anti-Doping Programme 2019.

The ITF Tennis Anti-Doping Programme 2019 is set out in full on the ITF website (www.itf.com/antidoping) and in a separate rulebook that is published and distributed by the TENNIS EUROPE to all National Associations. The ITF Tennis Anti-Doping Programme 2014 is also available upon application.

## ARTICLE VI: WELFARE POLICY

Any player and captain that is nominated and/or participates in TENNIS EUROPE Junior Team Competitions, and any Player Support Team Member of any player that is nominated and/or participates in the TENNIS EUROPE Junior Team Competitions shall be bound by and shall comply with the provisions of the Welfare Policy set out in Appendix D.

## ARTICLE VII: RECIPROCITY

The TENNIS EUROPE Manager reserves the right to affirm, modify or reject with respect to any or all TENNIS EUROPE Junior Team Competitions and TENNIS EUROPE Junior Circuit tournaments a suspension or other sanction issued against a Covered Person (as defined in the TENNIS EUROPE Welfare Policy, Appendix D) either by or on behalf of the TENNIS EUROPE pursuant to a conduct or disciplinary process under any TENNIS EUROPE code or policy or by any national or regional association or other tennis organisation including the Women's Tennis Association and Association of Tennis Professionals.

The Manager reserves the right in its absolute discretion to share information concerning any complaint against a Covered Person with and/or conduct an investigation in conjunction with any other national or regional association or any other tennis organisation or any other relevant authorities. The TENNIS EUROPE Manager may also refer the complaint and/or any information received during the course of investigating an allegation or prosecuting a charge to any authorities it considers appropriate in its absolute discretion. The TENNIS EUROPE shall have the absolute discretion, where it deems appropriate, to stay its own investigation pending the outcome of investigations being conducted by any national or regional association, any other tennis organisations and/or any relevant authorities. A Covered Person may petition the Committee for discretionary review of the determination of the TENNIS EUROPE Manager.

## ARTICLE VIII: INTERPRETATIONS



Any person or entity subject to this Code may file with the TENNIS EUROPE Manager of Junior Tennis a request for an interpretation or clarification of the Code and／or its applicability and effect on a particular event or transaction．

## ARTICLE IX：NOTICE

## A．PLAYER

Notice that a player is being investigated pursuant to a possible Major Offence charge shall be served personally upon him．Service of any other document required by the Code shall be deemed complete if mailed to the subject player at his home address or other address designated by the player，along with a copy to any player association of which he is a member provided that the TENNIS EUROPE Manager of Junior Tennis has notice of such membership．

## B．JUNIOR TEAM COMPETITION EVENT

Service of any document on an TENNIS EUROPE Junior Team Competition event as required by this Code shall be deemed complete if mailed to the TENNIS EUROPE Junior Circuit Tournament Director．

## ARTICLE X：AMENDMENTS

This TENNIS EUROPE Junior Team Competitions Code of Conduct may only be amended， repealed or otherwise modified，in whole or in part，by the TENNIS EUROPE．

## APPENDIX 5

## Medical, Extreme Weather Conditions and Toilet/Change of Attire Breaks

## Medical

## a. Medical Condition

A medical condition is a medical illness or a musculoskeletal injury that warrants medical evaluation and/or medical treatment by the Sports Physiotherapist (also known as the Primary Health Care Provider) during the warm-up or the match.

- Treatable Medical Conditions
- Acute medical condition: the sudden development of a medical illness or musculoskeletal injury during the warm-up or the match that requires immediate medical attention.
- Non-acute medical condition: a medical illness or musculoskeletal injury that develops or is aggravated during the warm-up or the match and requires medical attention at the changeover or set break.
- Non-Treatable Medical Conditions
- Any medical condition that cannot be treated appropriately, or that will not be improved by available medical treatment within the time allowed.
- Any medical condition (inclusive of symptoms) that has not developed or has not been aggravated during the warm-up or the match.
- General player fatigue.
- Any medical condition requiring injections, intravenous infusions or oxygen, except for diabetes, for which prior medical certification has been obtained, and for which subcutaneous injections of insulin may be administered.


## b. Medical Evaluation

During the warm-up or the match, the player may request through the Chair Umpire for the Sports Physiotherapist, in conjunction with the Tournament Doctor, to evaluate him/her during the next change over or set break. Only in the case that a player develops an acute medical condition that necessitates an immediate stop in play may the player request through the Chair Umpire for the Sports Physiotherapist to evaluate him/her immediately.

The purpose of the medical evaluation is to determine if the player has developed a treatable medical condition and, if so, to determine when medical treatment is warranted. Such evaluation should be performed within a reasonable length of time, balancing player safety on the one hand, and continuous play on the other. At the discretion of the Sports Physiotherapist, such evaluation may be performed in conjunction with the Tournament Doctor, and may be performed off-court. *

If the Sports Physiotherapist determines that the player has a non-treatable medical condition, then the player will be advised that no medical treatment will be allowed.

## c. Medical Time-Out

A Medical Time-Out is allowed by the Referee or Chair Umpire when the Sports Physiotherapist has evaluated the player and has determined that additional time for medical treatment is required. The Medical Time-Out takes place during a change over or set break, unless the Sports Physiotherapist determines that the player has developed an acute medical condition that requires immediate medical treatment.

The Medical Time-Out begins when the Sports Physiotherapist is ready to start treatment. At the discretion of the Sports Physiotherapist, treatment during a Medical Time-Out may take place offcourt, and may proceed in conjunction with the Tournament Doctor.

The Medical Time-Out is limited to three (3) minutes of treatment. However, at non-professional events, the Referee may extend the time allowed for treatment if necessary.

A player is allowed one (1) Medical Time-Out for each distinct treatable medical condition. All clinical manifestations of heat illness shall be considered as one (1) treatable medical condition. All treatable musculoskeletal injuries that manifest as part of a kinetic chain continuum shall be considered as one (1) treatable medical condition.

Muscle Cramping: A player may receive treatment for muscle cramping only during the time allotted for change of ends and/or set breaks. Players may not receive a Medical Time-Out for muscle cramping.

In cases where there is doubt about whether the player suffers from an acute medical condition, non-acute medical condition inclusive of muscle cramping, or non-treatable medical condition, the decision of the Sports Physiotherapist, in conjunction with the Tournament Doctor, if appropriate, is final. If the Sports Physiotherapist believes that the player has heat illness, and if muscle cramping is one of the manifestations of heat illness, then the muscle cramping may only be treated as part of the recommended treatment by the Sports Physiotherapist for the heat illness condition.


Note:
A player who has stopped play by claiming an acute medical condition, but is determined by the Sports Physiotherapist and/or Tournament Doctor to have muscle cramping, shall be ordered by the Chair Umpire to resume play immediately.

If the player cannot continue playing due to severe muscle cramping, as determined by the Sports Physiotherapist and/or Tournament Doctor, he/she may forfeit the point(s)/game(s) needed to get to a change of end or set-break in order to receive immediate evaluation, and treatment if time allows. There may be a total of two (2) additional change of ends treatments for muscle cramping in a match, not necessarily consecutive.

If it is determined by the Chair Umpire or Referee that gamesmanship was involved, then a Code Violation for Unsportsmanlike Conduct could be issued.

A total of two (2) consecutive Medical Time-Outs may be allowed by the Referee for the special circumstance in which the Sports Physiotherapist determines that the player has developed at least two (2) distinct acute and treatable medical conditions. This may include: a medical illness in conjunction with a musculoskeletal injury; two or more acute and distinct musculoskeletal injuries. In such cases, the Sports Physiotherapist will perform a medical evaluation for the two or more treatable medical conditions during a single evaluation, and may then determine that two consecutive Medical Time-Outs are required.

## d. Medical Treatment

A player may receive on-court medical treatment and/or supplies from the Sports Physiotherapist and/or Tournament Doctor during any changeover or set break. As a guideline, such medical treatment should be limited to two (2) changeovers/set breaks for each treatable medical condition, before or after a Medical Time-Out, and need not be consecutive. Players may not receive medical treatment for non-treatable medical conditions.

## e. Penalty

After completion of a Medical Time-Out or medical treatment, any delay in resumption of play shall be penalized by Code Violations for Delay of Game.

Any player abuse of this Medical Rule will be subject to penalty in accordance with the Unsportsmanlike Conduct section of the Code of Conduct.

## f. Bleeding

If a player is bleeding, the Chair Umpire must stop play as soon as possible, and the Sports Physiotherapist should be called to the court by the Chair Umpire for evaluation and treatment. The Sports Physiotherapist, in conjunction with the Tournament Doctor, will evaluate the source of the bleeding, and will request a Medical Time-Out for treatment if necessary.

If requested by the Sports Physiotherapist and/or Tournament Doctor, the Referee may allow up to a total of five (5) minutes to assure control of the bleeding.


If blood has spilled onto the court or its immediate vicinity, play must not resume until the blood spill has been cleaned appropriately.

If a player is vomiting, the Chair Umpire must stop play if vomiting has spilled onto the court, or if the player requests medical evaluation. If the player requests medical evaluation, then the Sports Physiotherapist should determine if the player has a treatable medical condition, and if so, whether the medical condition is acute or non-acute.

If vomiting has spilled onto the court, play must not resume until the vomit spill has been cleaned appropriately.

## h. Incapacity

If any concern arises about a player's medical condition (whether physical or psychological) they are unable to compete, or they pose a serious health risk to players, officials or tournament organisers or staff, the Sports Physiotherapist and/or Tournament Doctor should be called to assist the player.

If the issue arises during a match, the Chair Umpire should immediately call for the Tournament Doctor and/or Sports Physiotherapist to assist the player.

The Tournament Doctor is responsible for ensuring that the player is afforded the best medical attention, that his/her well-being is not put at risk, and that his/her medical condition is not a risk to other players or the public at large. All discussions between the Tournament Doctor and the player take place within the context of a doctor-patient relationship and are therefore confidential and may not be divulged to a third party without the informed consent of the player.
However, if the Tournament Doctor determines that the player's medical condition makes the player unable to participate safely in the tournament, the player must permit the Tournament Doctor to advise the Tennis Europe Supervisor of their determination (only disclosing medical information to which the player has consented). Upon receipt of such report from the Tournament Doctor, the Tennis Europe Supervisor will decide whether to retire the player from the match in progress or withdraw the player from the match to be played (as applicable). The Tennis Europe Supervisor shall use great discretion before taking this action, and should base the decision on the best interests of professional tennis, as well as taking all medical opinion and advice, and any other relevant information into consideration.

If the player's medical condition improves sufficiently to return to match play, the Tournament Doctor may inform the Tennis Europe Supervisor accordingly. At the discretion of the Tennis Europe Supervisor, the player may subsequently compete in another event at the same tournament, (e.g. doubles), either that day or on a subsequent day.

It is recognized that national laws or governmental or other binding Regulations imposed upon the tournament by authorities outside its control may require more compulsory participation by the Tournament Doctor in all decisions regarding diagnosis and treatment.

## EXTREME WEATHER CONDITIONS AND LIGHTNING

## a. Definitions

## Extreme Heat Condition: Modification of Play

Extreme Weather Conditions shall be defined as when the Heat Stress Index (Wet Bulb Globe Temperature (WBGT) Index) meets or exceeds $30.1^{\circ} \mathrm{C} / 86.2^{\circ} \mathrm{F}$. If the WBGT cannot be measured, then the Heat Index should be calculated using the chart below, and Extreme Heat Condition: Modification of Play criterion is defined as when the Heat Index meets or exceeds $34.0^{\circ} \mathrm{C}\left(93.2^{\circ} \mathrm{F}\right)$.

## Extreme Heat Condition: Suspension of Play

Extreme Heat Condition: Suspension of Play criterion is defined as when the WBGT on court meets or exceeds $32.2^{\circ} \mathrm{C}\left(90.0^{\circ} \mathrm{F}\right)$. If the WBGT cannot be measured, then the Heat Index should be calculated using the chart below, and Extreme Heat Condition: Suspension of Play criterion is defined as when the Heat Index meets or exceeds $40.1^{\circ} \mathrm{C}\left(104.2^{\circ} \mathrm{F}\right)$.

## b. Measurement Procedure

The WBGT or Heat Index should be measured at least three (3) times daily by the Tennis Europe Supervisor or his/her designee. Ideally, measurements should be taken every two (2) hours, but a minimum three (3) readings should be taken at the following times:
i. 30 minutes before match play begins;
ii. Middle of the scheduled day's play; and
iii. Just prior to beginning the last match of the day, or just prior to the start of the first evening session match.

The WBGT or Heat Index also should be measured under the following circumstances:
(a) Following any suspension of play; and
(b) At the discretion of the Tennis Europe Supervisor, in consultation with the Tournament Doctor and/or Sports Physiotherapist.

Details on the measurement of WBGT and Heat Index are provided in the current edition of the ITF Guide to Recommended Health Care Standards for Tennis Tournaments.

## c. Extreme Heat Condition: Modification of Play

When the Extreme Heat Condition - Modification of Play criterion is met before the start or resumption of a match, the procedures set out below in sub-section (d) should be followed. For the avoidance of doubt, the Tennis Europe Supervisor has the discretion to apply the procedures set out in sub-section (d) at a WBGT or Heat Index below the Extreme Heat Condition: Modification of Play criterion, if in his or her opinion it is required in the safety and wellbeing of players, officials, spectators or others.

If there is a change in weather conditions and the Extreme Heat Condition: Modification of Play criterion is met while a match is in progress, as determined by the periodic monitoring set out above in sub-section (b), the procedures set out below in sub-section (d) should be followed on all courts, including matches already in progress. Once notified that the Extreme Weather Condition: Modification of Play criterion is met, the Chair Umpire must inform the players at the next change of ends or set break.

If there is a change in weather conditions and the Extreme Heat Condition: Modification of Play criterion is no longer met, as determined by the periodic monitoring set out above in sub-section (b), those matches already in progress should continue to follow the procedures set out below in sub-section (d) until they are completed or suspended.

## d. Modification of Play Procedures (Singles \& Doubles)

A 10-minute break will be allowed between the second and third sets (in a best of 3 sets match) if one or more of the players requests such a break. If neither/none of the players requests such a break, then play will continue.


However, if a match has already resumed following the suspension of play and one set was completed before the suspension of play (in a best of 3 sets match), the 10 -minute break will no longer be available, unless otherwise decided by the Tennis Europe Supervisor.

The Tennis Europe Supervisor, in consultation with the Tournament Doctor/Sports Physiotherapist, may choose to delay the starting time for matches until such a time as the Extreme Heat Condition: Modification of Play criterion is no longer met.
i. During the 10-minute break:
a. No coaching is allowed.
b. A Medical Evaluation, Medical Time-Out or Medical Treatment is not allowed, unless approved by the Tennis Europe Supervisor. This would normally be restricted to requests for the Tournament Doctor/Sports Physiotherapist that are made on-court to the Chair Umpire, or were already agreed before the end of the second set (in a best of 3 sets 73 match). However, a player is allowed to receive an adjustment of medical support, medical equipment and/or medical advice from the Tournament Doctor/Sports Physiotherapist during the 10-minute break.
ii. Immediately following the 10-minute break:
a. Any delay in resumption of play will subject a player to Time Violations (Warning, Point Penalties only apply).
b. No re-warm up is allowed.
c. A player is not allowed to receive a Medical Evaluation, Medical TimeOut or Medical Treatment, unless approved by the Tennis Europe Supervisor.
iii. Consecutive Breaks

An Extreme Weather Condition: Modification of Play 10-minute break and a Bathroom/Change of Attire break cannot be taken consecutively.
e. Extreme Heat Condition: Suspension of Play (Singles and Doubles)

When the Extreme Heat Condition: Suspension of Play criterion is met before the start or resumption of a match, the start or resumption of play should be suspended until Extreme Heat Condition: Suspension of Play criterion is no longer met. If a game is in progress when the Extreme Heat Condition: Suspension of Play criterion is met, play should be suspended at the end of that game. Once the Extreme Heat Condition: Suspension of Play criterion is no longer met, the Tennis Europe Supervisor should give the players reasonable notice of the time at which play will resume. For the avoidance of doubt, the Tennis Europe Supervisor has the discretion to suspend play at a WBGT or Heat Index below the Extreme Heat Condition: Suspension of Play criterion, if in his or her opinion it is required in the safety and wellbeing of players, officials, spectators or others.

## e. Lightning

The Tennis Europe Supervisor or his/her designee is responsible for monitoring the local weather for lightning. The Tennis Europe Supervisor has the authority to suspend play when a thunderstorm appears imminent (for instance if lightning is sighted and thunder occurs in 30 seconds or less). Everyone on-site should be advised to seek appropriate shelter immediately. Play should not resume until the likelihood of a lightning strike has passed (as a guideline, at least 30 minutes after the last lightning strike is seen and the last sound of thunder is heard). Additional information on thunderstorms and lightning is provided in the ITF Guide to Recommended Health Care Standards for Tennis Tournaments.

## TOILET/CHANGE OF ATTIRE BREAK

A player is allowed to request permission to leave the court for a reasonable time for a toilet break/change of attire break (girls' matches). Toilet breaks/change of attire breaks must be taken on a set break. In girls' singles matches a player is entitled to one (1) break during a match. In boys' singles matches a player is entitled to one (1) toilet break during a match.
In a doubles match, and in any singles matches played with a reduced format of two tiebreak sets and a match tiebreak, a toilet break/change of attire break is not permitted before the match tiebreak. In a doubles match, each team is entitled to two (2) breaks. If partners leave the court together, it counts as one (1) break. If only one player leaves the court, it also counts as one (1) break.

These breaks may be taken for toilet visits, change of attire (girls' matches), or both, but for no other reason whatsoever. Any time a player leaves the court for a toilet break, it is considered one of the authorised breaks regardless of whether or not the opponent has left the court. Any toilet break taken after a warm-up has started is considered one of the authorised breaks.

Toilet breaks not taken on a set break will be authorised but will be penalised in accordance with the Point Penalty Schedule if the player is not ready to play within the allowed time. The Referee shall have the authority to deny a player permission to leave the court during a match for a toilet and/or change of attire break if it is interpreted by the Referee as gamesmanship and/or flagrant abuse of the Rules. A player should not take a toilet/change of attire break and a medical time out consecutively unless approved by the Referee. A player may change her attire during a toilet break.

Any player abuse of this rule will be subject to penalty in accordance with the Unsportsmanlike Conduct section of the Code of Conduct.


## APPENDIX 6

## TENNIS EUROPE WELFARE POLICY

Any team member, coach, trainer, manager, agent, medical or para-medical personnel and/or family member, tournament guest, credentialed person or other similar associate of any player or team (together "Player Support Team Member") and player and any tournament personnel, such as an official, tournament director, staff, volunteer, sponsor, health care provider, Tennis Europe staff member and members of the media (together "Credentialed Person") shall conduct himself/herself in a professional manner at all times and in accordance with this Tennis Europe Welfare Policy. In this Tennis Europe Welfare Policy Player Support Team Members, players and Credentialed Persons shall be defined as "Covered Persons".
a. Elements of the Welfare Policy.Tennis Europe
i. Application
a) Covered Persons shall be familiar with, and must abide by, this Tennis Europe Welfare Policy.

## ii. Unfair and/or Discriminatory Conduct

a) Covered Persons shall not engage in unfair or unethical conduct including any attempt to injure, disable or intentionally interfere with the preparation or competition of any player.
b) Covered Persons shall not discriminate in the provision of services on the basis of race, ethnicity, gender, national origin, religion, age or sexual orientation.
iii. Abuse of Authority; Abusive Conduct
a) Covered Persons shall not abuse his or her position of authority or control, and shall not attempt to or compromise the psychological, physical or emotional wellbeing of any player.
b) Covered Persons shall not engage in abusive conduct, either physical or verbal, or threatening conduct or language directed toward any Covered Person, parent, spectator or member of the press/media.
c) Covered Persons shall not exploit any player relationship to further personal, political or business interests at the expense of the best interests of the player.

## iv. Sexual Conduct

In order to prevent sexual abuse and the negative consequences resulting from the imbalance of a dual relationship, sexual conduct of any kind between any player and his/her Player Support Team Members and/or Credentialed Persons is discouraged.

In addition, the following conduct is specifically prohibited:

a) Covered Persons shall not make sexual advances towards, or have any sexual contact with, any player who is (i) under the age of 17, or (ii) under the age of legal majority in the jurisdiction where the conduct takes place or where the player resides.
b) Covered Persons shall not sexually abuse a player of any age. Sexual abuse is defined as the forcing of sexual activity by one person on another person (i) of diminished mental capacity; or (ii) by the use of physical force, threats, coercion, intimidation or undue influence.

Covered Persons shall not engage in sexual harassment - for example, by making unwelcome advances, requests for sexual favours or other verbal or physical conduct of a sexual nature where such conduct may create an intimidating, hostile or offensive environment.

Player Support Team Members and Credentialed Persons shall not share a hotel room with a player who is (1) under the age of 17 , or (2) under the age of legal majority in the jurisdiction where the hotel is located or where the player resides, unless such Player Support Team Member or Credentialed Person is the player's parent or is related to the player and authorised in writing by the player's parent. Player Support Team Members and Credentialed Persons shall not share a hotel room with a player at any time, unless such Player Support Team Member or Credentialed Person is the player's parent or is related to the player and authorised in writing by the player's parent. Penalties will apply to any underage player who is found to have violated this Hotel Room Policy. These penalties can include: forfeiture of points from the tournament(s) where the violation occurred and/or monetary fines equal to the amount of the hotel room rates and/or forfeiture of hotel per diem rates as applicable, for the tournament(s) where the violation occurred. Such penalty shall be in addition to any penalties that may be imposed on the Player Support Team Member or Credentialed Person pursuant to sub-Section b) below.
v. Criminal Conduct - Covered Persons shall comply with all relevant criminal laws. For greater certainty and without limiting the foregoing, this obligation is violated if a Covered Person has been convicted of or entered a plea of guilty or no contest to a criminal charge or indictment involving (a) an offence involving use, possession, distribution or intent to distribute illegal drugs or substances, (b) an offence involving sexual misconduct, harassment or abuse, or (c) an offence involving child abuse. Further, this obligation may be violated if a Covered Person has been convicted of or entered a plea of guilty or no contest to an offence that is a violation of any law specifically designed to protect minors.
vi. Anti-Doping Activity - Covered Persons shall not commit any offence under the terms of the ITF Anti-Doping Programme or aid, abet, counsel or procure in any way any person's offence under that Programme.
vii. Conduct in General - Covered Persons shall not conduct himself or herself in a manner that will reflect unfavourably on the ITF, any tournament, event or circuit owned or sanctioned by the TENNIS EUROPE (the "TENNIS EUROPE Tournaments"), any player, official or the game of tennis.

## b. Violations/Procedures

Any individual who believes that any Covered Person has failed to meet his or her obligations under this Welfare Policy may file a written complaint with the Tennis Europe Head of Operations and Administration responsible for the Tennis Europe Tournament in which the complainant participates. That complaint shall identify the complainant and state specifically the nature of the alleged misconduct. Upon receipt of such a complaint, Tennis Europe Head

of Operations and Administration shall promptly initiate a review of the matter. Such review shall be carried out by the relevant Manager or Head of Department with responsibility for the Tennis Europe Tournament in which the complainant participates ("Tennis Europe Manager/Head"). Upon request by the Tennis Europe Manger/Head, the Tennis Europe Head of Operations and Administration shall have authority to issue a provisional suspension of the accused individual, pending the completion of the investigation and issuance of a final decision on the matter.

Upon review of the complaint and, where appropriate, additional investigation, the Tennis Europe Manager/Head may determine that the complaint does not merit further action. If the Tennis Europe Manager/Head determines that the complaint does merit further action, after notifying the accused individual of the charge(s) and giving the accused individual the opportunity to present his or her views to Tennis Europe Head of Operations and Administration or his/her designee, either in person or in writing, at the Tennis Europe Head of Operations and Administration discretion, the Tennis Europe Head of Operations and Administration may impose appropriate sanctions including (a) denial of privileges or exclusion of the person in question from any or all TENNIS EUROPE Tournaments, or (b) such other sanctions including monetary sanctions as the Tennis Europe Head of Operations and Administration may deem appropriate.

The Tennis Europe Head of Operations and Administration reserves the right to extend to any or all Tennis Europe Tournaments a suspension or other disciplinary action taken against a Covered Person by a National or Regional Association or other tennis organisation such as the Women's Tennis Association and Association of Tennis Professionals or a conviction or plea of guilty or no contest to a criminal charge or indictment as set out in Section a) v. above. Tennis Europe Head of Operations and Administration reserves the right to share information concerning a complaint with and/or conduct an investigation in conjunction with any tennis organisation as specified above. The Tennis Europe Head of Operations and Administration Director may also refer the complaint and/or any information received during the course of investigating an allegation or prosecuting a charge to any authorities it considers appropriate. The Tennis Europe Head of Operations and Administration shall have the absolute discretion, where it deems appropriate, to stay its own investigation pending the outcome of investigations being conducted by other tennis organisations as specified above and/or relevant authorities.

Decisions of the Tennis Europe Head of Operations and Administration Executive Director may be appealed to the Committee responsible for the Tennis Europe Tournament in which the complainant participates, unless such decision involves the imposition of a suspension greater than one (1) year or a fine in excess of US $\$ 5,000$, in which case the appeal of such Tennis Europe Head of Operations and Administration decision shall be made to the Board of Management of Tennis Europe. In either circumstance, any appeal under this section must be filed with the appropriate body in writing within one month from the date of the notice of the Tennis Europe Head of Operations and Administration decision which is the subject of the appeal. The notice of appeal must include a statement of the reasons and arguments why the decision was incorrect and include supporting evidence and make any application for a stay of execution. In either circumstance, the appellate body shall decide whether to review the appeal based solely on the Tennis Europe Head of Operations and Administration investigation or whether to hold a full hearing in which the Covered Person will be given the opportunity to present his/her case directly to the appellate body, in which case the appellate body shall issue directions for the efficient conduct of the appeal. The decision of the Tennis Europe Committee or Tennis Europe Board of Management shall be final and binding. Any decision of the Tennis Europe Head of Operations and Administration decided on the basis of a conviction or plea of
guilty or no contest to a criminal charge or indictment as set out in Section a) v. above shall be final and binding.
v. Any decision of the Tennis Europe Head of Operations and Administration and/or the Tennis Europe Committee and/or the Tennis Europe Board of Management pursuant to this Welfare Policy may be communicated to those Member National Associations, other tennis organisations and Tennis Europe Tournament organisers deemed necessary by the Tennis Europe Head of Operations and Administration and/or the Tennis Europe Committee and/or the Tennis Europe Board of Management.

## APPENDIX 7

THE PLAYERS

## 1. Definition of "Good Standing" of a Player

Any player selected by a Nation to take part in a Tennis Europe Junior Team Competitions must be of Good Standing. The National Tennis Association of the Nation for which the player is to be selected shall determine whether the player is of Good Standing before he/she is selected to take part in the Tennis Europe Junior Team Competitions.

A National Tennis Association shall deem a player to be of good standing where he/she is:
(a) is free from a suspension imposed by his/her National Tennis Association, or by the TENNIS EUROPE, or through the imposition of a suspension under a Code of Conduct accepted and approved by the TENNIS EUROPE.
(b) is accepted by the National Tennis Association as being under its jurisdiction while competing in events for which the National Tennis Association has selected such player.
(c) makes himself/herself available for selection for TENNIS EUROPE Junior Circuit tournaments, for official team championships, including the Olympic Games and Youth Olympic Games, and accepts the jurisdiction of the National Tennis Association while competing in events for which they have selected him/her.
(d) respects the spirit of fair play and non-violence at all times;
(e) accepts the conditions of entry of the events such player enters, including the conditions of any Code of Conduct adopted for those events and the terms and conditions contained in the IPIN registration system.
(f) agrees to undergo any medical control, including gender control and/or other tests, which are in operation at any event which such player enters.
$(\mathrm{g})$ has not been convicted by a competent court of a country of an offence:
(i) in respect of which an unsuspended sentence of at least 12 months was imposed; or
(ii) which involved any act or omission which would reasonably be considered by the TENNIS EUROPE to compromise the integrity of tennis, the National Tennis Association, the TENNIS EUROPE and/or the safety of those taking part in and/or attending an TENNIS EUROPE Junior Circuit tournament, an official team championships, the Olympic Tennis Event and Youth Olympic Tennis Event; or
(h) has not otherwise engaged in conduct which brings the national tennis association and/or the TENNIS EUROPE into disrepute.
A player who fails to satisfy any of the criteria at (a)-(h) above must establish to the satisfaction of the National Tennis Association that he/she is of good standing notwithstanding his/her failure.
Any appeal against a final decision handed down by a national tennis association with respect to g ) and h) shall be lodged with the TENNIS EUROPE Juniors Committee within 21 days of notification of the decision in question. Recourse may only be made to the TENNIS EUROPE Juniors Committee after all other internal channels of appeal to a National Tennis Association have been exhausted. The decision of the TENNIS EUROPE Juniors Committee shall be final and binding. The TENNIS EUROPE Juniors Committee in its absolute discretion may set aside the determination of a National Tennis Association.

2. Definition of a "National"

A national of a country is a player who is eligible for and holds a passport of that country and for the purposes of Regulation 26, the tennis nationality of a player shall be:
(a) In the case of a player who has represented a country, that of the country which he last represented.
In all other cases, that of the country which he is for the time being qualified to represent under Regulation 26.

## 3. Gender Verification

In any competition, a player may be required upon request to submit to gender verification to determine sexual status.
In the event that the gender of a player is questioned, the medical delegate (or equivalent) of the TENNIS EUROPE shall have the authority to take all appropriate measures for the determination of the gender of a competitor.
The results of any tests conducted will not be made public out of deference to the human rights of the individual concerned but will be reported to the Chairman of the TENNIS EUROPE Sport Science and Medicine Commission who shall advise the Board of Directors of the gender of the player concerned.
Failure by a player to submit to testing upon the request of the TENNIS EUROPE shall subject the player to immediate suspension from the competition until such time as the appropriate testing is carried out in accordance with these Regulations.

Transsexuals
Any individuals undergoing sex reassignment from male to female before puberty are regarded as girls and women (female), while those undergoing reassignment from female to male are regarded as boys and men (male).
Individuals undergoing sex reassignment from male to female after puberty (and the converse) are eligible for participation in female or male competitions, respectively, under the following conditions:
a. Surgical anatomical changes have been completed, including external genitalia changes and gonadectomy.
b. Legal recognition of their assigned sex has been conferred by the appropriate official authorities.
c. Hormonal therapy appropriate for the assigned sex has been administered in a verifiable manner and for a sufficient length of time to minimise gender-related advantages in sport competitions.
d. Eligibility should begin no sooner than two years after gonadectomy.

In all instances, a confidential case-by-case evaluation will occur.

The loser of the 2nd day's consolation match $(Z)$ will be definitively eliminated and will be ranked Nr. 7.

3rd day: Final 1st/2nd place: winner N - winner M
Match 3rd/4th place: $\quad$ loser $\mathrm{N}^{\prime}$ - loser $\mathrm{M}^{\prime}$
Match 5th/6th place: loser $\mathrm{H}^{\prime}$ or $\mathrm{I}^{\prime}$ or $\mathrm{L}^{\prime}$ against the team that did not play on the 2nd day (=X-Y).

Free day: Team Z
Each team can play at least two ties. Even if the seeded Nr. 1 team (G) loses its first tie, it will play for the 3rd/4th place.
